Formal tenders sealed and clearly marked “**TD 07/09/2023: DEVELOPMENT AND MANAGEMENT OF AIRPORT FOR A CONTRACT PERIOD ENDING 30 JUNE 2033**” must be placed in the Municipal tender box, **26 Church Street, OUDTSHOORN** no later than 12h00 on **30 NOVEMBER 2023** and will be opened in public immediately thereafter in the **Supply Chain Management Office, 26 Church Street, OUDTSHOORN** or any alternative place in Oudtshoorn Municipal Offices.

A set of fully completed tender documents must be submitted on the original documents and remain valid for a maximum of 120 days after the closing date of the tender. A set of tender documents can be obtained at a non-refundable cost of **R361-00 including VAT** for hard copies directly printed by the Municipality and free of charge when provided on pdf via e-mail. Then hard copies will be physically handed only to prospective bidders who produce a receipt for the payment of the tender document at the SCM Offices.

The municipality reserves the right to withdraw any invitation to tender and / or re-advertise or to reject any formal tender or to accept a part of it. The Municipality does not bind itself to accept the lowest or award a contract to the bidder scoring the highest number of points. Potential bidders should note that all projects in terms of this tender may not materialize.

Functionality will be applicable. Bidders should score a minimum of 70 out of 100 to be evaluated further.

Formal Tender TD 07/09/2023 will be evaluated and adjudicated in terms of **80/20** Preference Point System prescribed by the Preferential Procurement Policy Framework Act (2022) and the Municipality's Supply Chain Management Policy.
