1. INTRODUCTION AND PURPOSE

The Environment and Agriculture Management Department (hereafter referred to as “the Department”) of the City of Tshwane is requesting for responsive bidders to submit quotation for the supply, delivery, installation, configuration, and maintenance of a complete indoor and outdoor CCTV surveillance camera system and alarm system at BooySENS Nursery.

The purpose of this project is to secure the BooySENS Nursery and create a safe environment for the staff and customers.

2. BACKGROUND

How was this bid/project identified?

As part of the 2021/22 CAPEX budget allocation, the Environment and Agriculture Management Department will be embarking on a project aimed at supply, delivery, installation, configuration, and maintenance of a complete indoor and outdoor CCTV surveillance camera system and alarm system at BooySENS Nursery in the City of Tshwane. It is against this background that the Department is presenting the specification as outlined below.

The aim and objectives of the project:

This project seeks to secure the Booyens Nursery and create a safe environment for the staff and customers through the installation, configuration, and maintenance of a complete indoor and outdoor CCTV surveillance camera system and alarm system.

What control and monitoring measures are envisaged?

The implementation of the project will be guided by the specification, drawings and project implementation plan to deliver the project within the approved timeframes and budget. A specialist will be sourced internally to monitor the project for quality assurance.

Other: The payment plan for this project comprises of two stages:

- Stage 1: Completion of alarm system
- Stage 2: Completion for CCTV cameras system
- Stage 3: Maintenance of all wireless network 5ghz bullet cameras and alarm system.

The appointed contractor is required to provide an invoice as part of the partial payment upon completion of the above-mentioned project stages/milestones.

There are existing facilities at the Booyens Nursery that must be utilized by the appointed contractor for site storage during implementation

3. PROJECT SCOPE

The City of Tshwane seeks to appoint a service provider that will contribute to ensuring that the Environment and Agriculture Management Department improve the security infrastructure at Booyens Nursery.

The scope of work includes the installation, configuration, and maintenance of a complete indoor and outdoor CCTV surveillance camera system and alarm system at Booyens Nursery.

The quotation comprises of the following items:

3.1	Install wireless network 5ghz bullet cameras.
3.2	Installation and configuration of an alarm system.
3.3	Maintenance of all wireless network 5ghz bullet cameras
3.4	Maintenance of all alarm system

4. DELIVERABLES

The project must be completed within one (1) month after the appointment date and no later than 30 June 2022. The bidder should provide an indicative project implementation plan on how the project will be implemented.

A detailed implementation program shall be submitted within ten (10) working days after the appointment date. Work to commence immediately upon signing of the Service Level Agreement (SLA) if applicable.

5. EVALUATION STAGES

5.1 ADMINISTRATIVE COMPLIANCE

All the proposals will be evaluated against the administrative responsiveness requirements as set out in the SCM list of returnable documents.

5.2 LOCAL CONTENT AND PRODUCTION

CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.

- 2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.

- 3 Municipal Supply Regulation 38 (1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;
 - b. reject the bid of any bidder if that bidder or any of its directors has abused the supply chain management system of the municipality or municipal entity or has committed any improper conduct in relation to such system; and
 - c. cancel a contract awarded to a person if the person committed any corrupt or fraudulent act during the bidding process or the execution of the contract.

- 4 This MBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.

7. In particular, without limiting the generality of paragraphs 6 above, there has been no consultation, communication, agreement or arrangement with any competitor regarding:
 - (a) prices;
 - (b) geographical area where product or service will be rendered (market allocation)
 - (c) methods, factors or formulas used to calculate prices;
 - (d) the intention or decision to submit or not to submit, a bid;
 - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
 - (f) bidding with the intention not to win the bid.
8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.
9. The terms of the accompanying bid have not been, and will not be, disclosed by the bidder, directly or indirectly, to any competitor, prior to the date and time of the official bid opening or of the awarding of the contract.

³ Joint venture or Consortium means an association of persons for the purpose of combining their expertise, property, capital, efforts, skill and knowledge in an activity for the execution of a contract.

10. I am aware that, in addition and without prejudice to any other remedy provided to combat any restrictive practices related to bids and contracts, bids that are suspicious will be reported to the Competition Commission for investigation and possible imposition of administrative penalties in terms of section 59 of the Competition Act No 89 of 1998 and or may be reported to the National Prosecuting Authority (NPA) for criminal investigation and or may be restricted from conducting business with the public sector for a period not exceeding ten (10) years in terms of the Prevention and Combating of Corrupt Activities Act No 12 of 2004 or any other applicable legislation.
