## 1. Background

The Moses Kotane Institute is an entity of the KwaZulu-Natal (KZN) Provincial Government through the Department of Economic Development, Tourism and Environmental Affairs (EDTEA), with a mandate to conduct world-class research into training, skills development, and provincial strategic economic sectors; and to strategically lead on innovation and maritime coordination and implementation activities to respond to the needs of the provincial economy. MKI generally aims to provide timely and accurate research to support the attainment of radically transformed inclusive and sustainable economic growth for the province in partnerships with the public and private sectors.

MKI invites suitable service providers to submit their quotations as per the specification below.

- a) 1 metre, 8 mm, Galvanized chain with SS D-shackles to secure the trailer to the hitch
- b) SS turnbuckle, M8, 1 metre, 6 mm Galvanized chain and SS D-shackles to secure boat bow eye to the trailer
- c) 6 x Spark plugs - NGK BR8HS-10 (Standby spares)
- d) 1 x Spark plug Socket 1/2" Drive
- e) 1 x Wheel spanner for trailer wheel nuts Memo – Vessels Maintenance Equipment
- f) 2 x 85 Yamaha water pump impellers
- g) 2 x SS Ratchet straps (Heavy duty), 32 mm, 2 pieces, with hooks to secure the boat stern to the trailer. one for each side, Port and Starboard
- h) 2 x SS Ratchet straps (Heavy duty), 32 mm, 1 piece (continuous) to secure outboard motors to trailer on long trips
- i) Commercial Towstrap with 12 mm D shackle to pull the boat from the water before winching onto the trailer
- j) 1 x Length of pine plank cut to support motors (Scaffold plank – Pine)
- k) 12 mm Garden hose with fittings plus spray nozzle (Heavy duty) for the boat – pre-warming of outboard motors before launching and washing the boat afterwards
- l) Flush muffs (with round cups) with garden hose fitting to attach the garden hose to clamp over engine water-inlet to pre-warm outboard motors
- m) Victron Battery Charger 12 V, 10 A with charging cables for boat batteries when not in use IP-65
