1. No services must be rendered or goods delivered before an official Broadband Infraco Purchase Order form has been received.
2. Late and incomplete submissions will not be accepted.
3. Any bidder who has reasons to believe that the RFQ specification is based on a specific brand must inform Broadband Infraco before RFQ closing date.
4. Where applicable, Work will be carried out in terms of the OHSA and regulations and therefore it is important for the bidders to include OHSA compliance costs (i.e safety file for the recommended bidder will be approved by Broadband Infraco).
5. **Bidder is required to submit copy of Tax Clearance Certificate and verification information (PIN) to be used by Broadband Infraco to validate the copy on the SARS website for all price quotations exceeding the value of R30 000 (VAT included). Failure to submit the copy of valid Tax Clearance Certificate and verification information will result in the invalidation of this RFQ. It is the responsibility of the bidder to ensure that Broadband Infraco is in possession of the bidder's valid Tax Clearance certificate. The onus is on the bidder to ensure that Broadband Infraco receives a valid Tax Certificate as soon as the validity of the said certificate expires.**

- iv) If the specific goals have been claimed or obtained on a fraudulent basis or any of the conditions of contract have not been fulfilled, the organ of state may, in addition to any other remedy it may have –
  - (a) disqualify the person from the tendering process;
  - (b) recover costs, losses or damages it has incurred or suffered as a result of that person's conduct;
  - (c) cancel the contract and claim any damages which it has suffered as a result of having to make less favourable arrangements due to such cancellation;
  - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
  - (e) forward the matter for criminal prosecution, if deemed necessary.

## **1. Background Information**

Broadband Infraco was subcontracted by Tata Communications to monitor and maintain the West Africa Cable System (WACS) submarine cable Primary NOC (PNOC) function for US\$207,097.00 per annum for a period of five (5) years starting 4th May 2020. The company is still contracted to provide WACS PNOC services until May-2026 BBI is responsible for the Primary Network operations centre (PNOC) in Sentech Honeydew, Johannesburg and Tata Telecommunications are responsible for the Failover network operations centre (FNOC) in Pune, India. The WACS system Upgrade-4 is currently under implementation, with partial acceptance scheduled for July 2023. Ciena was appointed as the original equipment manufacturer (OEM) to deliver this upgrade. A new network management link is required between the Yzerfontein cable landing station and the PNOC to enable monitoring of Ciena network equipment.
