**1. SCOPE**

This specification covers the requirements for 99,995% pure zinc ingots that conforms to this specification. (Zincor grade: SHG)

**2. APPLICABLE DOCUMENTS**

The material shall be supplied as ingots with a mass of ±30kg per ingot.

**4. QUALITY ASSURANCE PROVISIONS**

**4.1 Responsibility for inspection**

4.1.1 Unless otherwise specified in the contract or order, the supplier is responsible for the performance of all inspection requirements as specified herein.

4.1.2 Except where otherwise specified, the supplier may use his own or any other facilities suitable for the performance of the inspection requirements.

4.1.3 The purchaser or his representative reserves the right of inspection of Laboratory certificates of raw materials and components used for the manufacture of the material.

4.1.4 The supplier shall be responsible for making available to the purchaser all facilities necessary if required, for inspection of the material.



4.1.5 The supplier will be responsible for the implementation of an applicable quality management system to assure the appropriate quality of the product. The purchaser reserves the right to audit the supplier's production facilities at all times to ascertain whether quality requirements are being met.

5. **BATCH IDENTIFICATION**

5.1 The material shall be supplied in batches, where a batch is defined as the identifiable quantity of material produced by one manufacturer in one unchanged process, using the same materials and methods in accordance with the same specification.

5.2 The supplier shall ensure that all deliveries to the end user are fully traceable by batch number and that identification records be supplied to the end user to match batch number with inspection records.

6. **PREPARATION FOR DELIVERY**

Should a Tenderer/Vendor not be able to meet the requirements of this document, it must be declared in writing to the Buying Manager at the time of tendering/receipt of an order

6.1 **Packing**

6.1.1 The material must be supplied in strapped bundles suitable for forklift handling. The mass shall not exceed 3 000kg.

6.2 **Package marking**

All bundles, to be legibly and durably marked with the following details on suitable labels:

6.2.1 Document and order number.

6.2.2 Name of supplier.

6.2.3 Batch number.

6.2.4 Zinc grade and colour code ("Zinc 1" colour code: Red "S").
