- A submission submitted in response to this RFB will constitute a binding offer which will remain binding and irrevocable for a period of **one hundred and twenty (120) days** from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the RFB validity period is still in force. **(RFB Validity Period: 120 days from date of closure)**
- No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued to the awarded bidder.
- It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the RFB.

INTRODUCTION TO MHSC

The Mine Health and Safety Council (MHSC) is a national public entity (Schedule 3A) established in terms of the Mine Health and Safety Act, No. 29 of 1996, as amended. The MHSC is mandated to advise the Minister of the Department of Mineral and Petroleum Resources (DMPR) on mine health and safety (MHS) issues in the mining industry, relating to the development and implementation of the MHSC annual MHS research programme, reviewing and development of MHS legislation and dissemination (knowledge and technology transfer) of MHSC research outcomes to improve MHS conditions in the South African Mining Industry (SAMI).

Occupational exposure to respirable dust remains a major health risk in the SAMI, contributing to a large number of Occupational Lung Diseases (OLDs). Since 2014, over 11,000 cases of OLDs have been reported, with 248 new cases in 2022 alone (DMPR, 2023). These statistics underscore the urgency to improve dust control interventions as the industry works towards the milestone of eliminating OLDs by December 2034 (MHSC, 2024).

Globally, two primary strategies have proven effective in controlling respirable dust, namely, preventing dust from becoming airborne or removing it from ventilating air (Kissell, 2003). Within SAMI, water-based dust suppression spray systems are the most commonly adopted type of dust control due to their practicality and general effectiveness. However, variations in system design, application methods, and operational settings have led to inconsistent performance across mining operations (Cecala et al., 2012).

Insights from the Mine Occupational Safety and Health (MOSH) Dust Team have identified several recurring challenges affecting dust suppression system performance. These include unsuitable nozzle design, poor installation and positioning, suboptimal pressure levels, degraded water quality, and lack of routine maintenance, all of which contribute to poor dust suppression. Surface operations face additional challenges which may negatively influence dust suppression systems, including wind speed and direction, terrain variation, and

temperature fluctuations, which further compromise the efficacy of suppression systems (Ghose & Majee, 2007).

Despite the widespread adoption of these interventions, industry-specific, evidence-based guidance on selecting and configuring dust suppression systems remains limited. This gap has resulted in operational inefficiencies and inconsistent protection for mine employees.

This research proposes a comparative performance assessment of water-based and supplementary interventions for dust suppression spray systems used in both underground and surface mining operations within SAMI. The aim is to evaluate the efficiency and effectiveness of different systems under varied environmental and operational conditions and ultimately develop evidence-informed guidance to improve dust control strategies and enhance occupational health outcomes.

CONTEXT OF PROCUREMENT

The MHSC seeks to appoint a service provider to conduct a comparative performance assessment of water-based dust suppression spray systems and supplementary interventions used within the SAMI for both underground and surface mining operations.

In this document words in the singular also mean in the plural and vice versa, words in the masculine mean in the feminine and neuter, words “department” means organs of state inclusive of public entities and vice versa, and the words “will/should” mean “must”.

South African National Parks (MHSC) cannot amend the National Treasury’s General Conditions of Contract (GCC). MHSC appends Special Conditions of Contract (SCC) providing specific information relevant to a GCC clause that requires the addition of Special Conditions and Special Conditions specific to this bid contract is not part of the General Conditions of Contract. No clause in this document shall be in conflict with another clause. Whenever there is a conflict, the provisions of the Special Conditions of Contract shall prevail.

Notwithstanding the provisions of GCC Clauses 22 and 23, the supplier shall not be liable for forfeiture of its performance security, damages, or termination for default if and to the extent that his delay in performance or other failure to perform his obligations under the contract is the result of an event of force majeure. 25.2. The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice

The parties agree that all right, title, and interest in the contract intellectual property rightly invests in MHSC and to give effect to the foregoing: (a) The contracted supplier hereby assigns all rights, titles, and interests in and to the contract intellectual property that it may own to MHSC and MHSC hereby accepts such assignment, and (b) The contracted supplier undertakes to assign in writing to MHSC all contract intellectual property and which may invest in the contracted supplier. The contracted supplier shall keep the contract intellectual property confidential and shall fulfil its confidentiality obligations as set out in this document. The contracted supplier shall assist MHSC in obtaining statutory protection for the contract intellectual property at the expense of MHSC wherever MHSC may choose to obtain such protection. The contracted party shall procure where necessary the signatures of its personnel for the assignment of the contract intellectual property to MHSC, or as MHSC may direct, and to support MHSC, or its nominee, in the prosecution and enforcement thereof in any country in the world. The contracted supplier hereby irrevocably appoints MHSC to be its true and lawful agent in its own name, to do such acts, deeds, and things and to execute deeds, documents, and forms that MHSC, in its absolute discretion, requires in order to give effect to the terms of this clause.

	The rights and obligations set out in this clause shall service termination of this contract indefinitely.

The undertakings set out in this clause shall not apply to confidential information, which the recipient is able to prove: (a) Was independently developed by the recipient prior to its involvement with MHSC or in the possession of the recipient prior to its involvement with MHSC. (b) Is now or hereafter comes into the public domain other than by breach of this contract by the recipient. (b) All written transcripts of confidential information disclosed verbally by the MHSC; and (c) All material embodiments of the contract intellectual property. The recipient acknowledges that the confidential information made available solely for the execution of the contract and for no other purpose whatsoever and that the confidential information would not have been

Except as expressly herein provided, this contract shall not be construed as granting or confirming, either expressly or impliedly any rights, licences, or relationships by furnishing of confidential information by either party pursuant to this contract.
