3.1 Transnet has implemented a new electronic tender submission system, the e-Tender Submission Portal, in line with the overall Transnet digitalization strategy where suppliers can view advertised tenders, register their information, log their intent to respond to bids and upload their bid proposals/responses on to the system.

### 4. RFP INSTRUCTIONS

4.1 Please sign documents [sign, stamp, and date the bottom of each page] before uploading them on the system.

4.2 The person or persons signing the submission must be legally authorised by the respondent to do so.

**4.3 All returnable documents tabled in the Proposal Form [Section 5] must be returned with proposals.**

4.4 Unless otherwise expressly stated, all Proposals furnished pursuant to this RFP shall be deemed to be offers.

4.5 Any exceptions to this statement must be clearly and specifically indicated.

4.6 Any additional conditions must be embodied in an accompanying letter. Subject only to clause 15 [Alterations made by the Respondent to Bid Prices] of the General Bid Conditions, paragraph 12 below (Legal Review) and Section 6 of the RFP, alterations, additions or deletions must not be made by the Respondent to the actual RFP documents.

### 5. JOINT VENTURES OR CONSORTIUMS

5.1 Respondents who would wish to respond to this RFP as a Joint Venture [**JV**] or consortium with B-BBEE entities, must state their intention to do so in their RFP submission. Such Respondents must also submit a signed JV or consortium agreement between the parties clearly stating the percentage [%] split of business and the associated responsibilities of each party. If at the time of the bid submission such a JV or consortium agreement has not been concluded, the partners must submit confirmation in writing of their intention to enter into a JV or consortium agreement should they be awarded business by TNPA through this RFP process. This written confirmation must clearly indicate the percentage [%] split of business and the responsibilities of each party. In such cases, award of business will only take place once a signed copy of a JV or consortium agreement is submitted to Transnet.

Respondents are to note that for the purpose of Evaluation, a JV will be evaluated based on one consolidated B-BBEE score card (a consolidated B-BBEE Status Level verification certificate) as per the B-BBEE Preferential Procurement Regulations, 2022 preference point scoring.

## 6 COMMUNICATION

6.2 Respondents are to note that changes to its submission will not be considered after the closing date.

6.3 It is prohibited for Respondents to attempt, either directly or indirectly, to canvass any officer or employee of Transnet in respect of this RFP between the closing date and the date of the award of the business.

6.4 Respondents found to be in collusion with one another will be automatically disqualified and restricted from doing business with organs of state for a specified period.

6.5 Transnet will publish the outcome of this RFP in the National Treasury e-tender portal and Transnet website within 10 days after the award has been finalised. Respondents are required to check the National Treasury e-tender Portal and Transnet website for the results of the tender process. All unsuccessful bidders have a right to request Transnet to furnish individual reasons for their bid not being successful. ## 8. COMPLIANCE

8.1 The successful Respondent [hereinafter referred to as the **Service Provider**] shall be in full and complete compliance with any and all applicable laws and regulations.

## 9. EMPLOYMENT EQUITY ACT

9.1 Respondents must comply with the requirements of the Employment Equity Act 55 of 1998 applicable to it including (but not limited to) Section 53 of the Employment Equity Act.

## 10. DISCLAIMERS

10.1 Respondents are hereby advised that Transnet is not committed to any course of action as a result of its issuance of this RFP and/or its receipt of Proposals. In particular, please note that Transnet reserves the right to:

- modify the RFP's Goods/Services and request Respondents to re-bid on any such changes.

- reject any Proposal which does not conform to instructions and specifications which are detailed herein.
- disqualify Proposals submitted after the stated submission deadline [closing date].
- award a contract in connection with this Proposal at any time after the RFP's closing date.
- award a contract for only a portion of the proposed Goods/Services which are reflected in the scope of this RFP.
- **split award of the contract between more than one Service provider or award to more than one Service Provider (Multiple), should it at Transnet's discretion be more advantageous in terms of, amongst others, cost or developmental considerations.**
- cancel the bid process.
- validate any information submitted by Respondents in response to this bid. This would include, but is not limited to, requesting the Respondents to provide supporting evidence. By submitting a bid, Respondents hereby irrevocably grant the necessary consent to Transnet to do so.



**6.6 STEP FIVE: Post Tender Negotiations (if applicable)**
