## **1. PURPOSE**

The Kwazulu-Natal Growth Fund Trust (KGFT) invites quotations from the panel of suitably qualified service providers to provide KGFT with a secondment of experienced legal personnel for a period of three (3) to six (6) months in line with the scope as detailed under scope of service required.

## **2. BACKGROUND**

KZN Growth Fund Trust (KGFT) is a Trust, established and capitalised by the Provincial Government to provide debt and equity. The main objective of the KGFT is to provide support for creating and enabling environment for activities that create jobs and accelerate the economic development of KZN whilst promoting Broad Based Black Economic Empowerment (B-BBEE).

### **2.1 Procurement Philosophy**

It is the policy of KGFT, when purchasing goods and obtaining services to follow a course of optimum value and efficiency by adopting best purchasing practices in supply chain management, ensuring that open and fair competition has prevailed, with due regard being given to the importance of:

- a) The promotion, development and support of businesses from disadvantaged communities (small, medium, micro enterprises, as well as established businesses within those communities) in terms of its BEE Policy;
- b) The promotion of national and regional local service providers and agents before considering overseas service providers and;
- c) The development, promotion and support for the moral values that underpin the above, in terms of KGFT Business Ethics and Guidelines which requires that all commercial conduct be based on ethical and moral values and sound business practice. This value system governs all commercial behaviour within KGFT.

The KGFT wishes to engage with service providers who are equally committed to maintain high quality services and better pricing

### **3. SCOPE OF SERVICES REQUIRED**

Kwazulu-Natal Growth Fund Trust (KGFT) would like the service of a seconded Senior Legal Personnel for a period of three (3) to six (6) months spending maximum 3 days a week at the KGFT Offices. The detailed Job Specification is as per the below.

#### **Key Duties**

- Provide prompt managerial leadership to the KGFT Legal department in respect of project finance transactional law, equities and financial services law, procurement law, employment law, social media law, with a sound knowledge of corporate law.
- Manage delivery of legal due diligence assessments performed by legal department including, drafting, vetting and negotiations of all loan agreements or any other business-related agreement.
- Ensure that all aspects of legal risk are identified covered and controlled in the implementation of new projects, transactions, precedents, agreements, legal opinions, systems, procedures, and products
- Assist in developing and delivering strategic risk management initiatives which ensures that best practice is adopted in compliance with all guidelines including applicable laws, rules, and regulations.
- Manage legal documents outsourced to third party legal advisors, providing advice to the project investment unit, HR unit, Finance and Procurement unit.
- Proactively identify and manage legal and risk opportunities through providing sound advice in respect of process and procedure.
- Develop and implement initiatives and tools in-order to coach and guide business on legal requirements and risks in the project finance field to minimize and eliminate risk in this legal area.
- Keep management apprised of key compliance and default issues and possible ways of resolving such matters as well as the estimated risk that will arise from those issues.
- Provide legal support and management expertise to the broader KGFT.
- Attend due diligence assessments relating to KGFT's investments

#### **Experience**

- At least 5 - 8 years job related corporate and commercial law and banking and finance principles.
- Working knowledge of various computer programmes including Power Point, MS Word, Excel, and Outlook.
- In depth knowledge of laws and legal processes in respect of company core business (primarily relating to Project Finance, Corporate Finance, and Private Equity).

- Working knowledge of other areas of law e.g., Tax, Companies Act, Insolvency, Labour Law.
- Experience in legal due diligence.
