In terms of Section 110 of the Municipal Finance Management Act, 2003 (No. 56 of 2003), tenders are hereby invited for APPOINTMENT OF MAXIMUM OF TWO (2) SERVICE PROVIDERS FOR HVAC SYSTEMS REPAIRS, MAINTENANCE AND REPLACEMENTS ON ALL STLM MUNICIPAL FACILITIES (MP 313) FOR THE PERIOD OF 36 MONTHS AS AND WHEN REQUIRED, in the Steve Tshwete municipal region. **Tenderers should have a CIDB contractor grading of 2ME OR HIGHER.**

The tenders will be opened in public.

A non-compulsory clarification meeting will take place on 09/12/2025 starting at 15:00, at Library Auditorium, Gerard Sekoto Library, Civic Center, Cnr Walter Sisulu & Wanderers, Middelburg, 1050

Bidders will be evaluated on functionality whereby **70** points has to be attained before financial proposals can be looked at. A preferential point system shall apply whereby a contract will be allocated to a tenderer in accordance with the Preferential Procurement Policy Framework Act, Act No 5 of 2000 and as defined in the conditions of tender in the tender document, read in conjunction with the supply chain management policy of Steve Tshwete Local Municipality where **80** points will be allocated in respect of price and **20** points in respect of Specific Goals. Tenderers must have the necessary skills, experience and capacity to perform the required work.

No awards will be made to a person:

- Who is in the service of the state;
- If that person is not a natural person , of which any director, manager, principal shareholder or stakeholder is a person in the service of the state; and/or
- Who is an advisor or consultant contracted with the municipality or municipal entity.

The municipality reserves the right to withdraw any invitation to tender and/or to re-advertise or to reject any tender or to accept a part of it. The municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.
