The imposition and duration of the exclusion will be determined by the severity of the transgression. PREVIOUS TRANSGRESSIONS

SANCTIONS FOR VIOLATIONS

Transnet shall also take all or any one of the following actions, wherever required to:

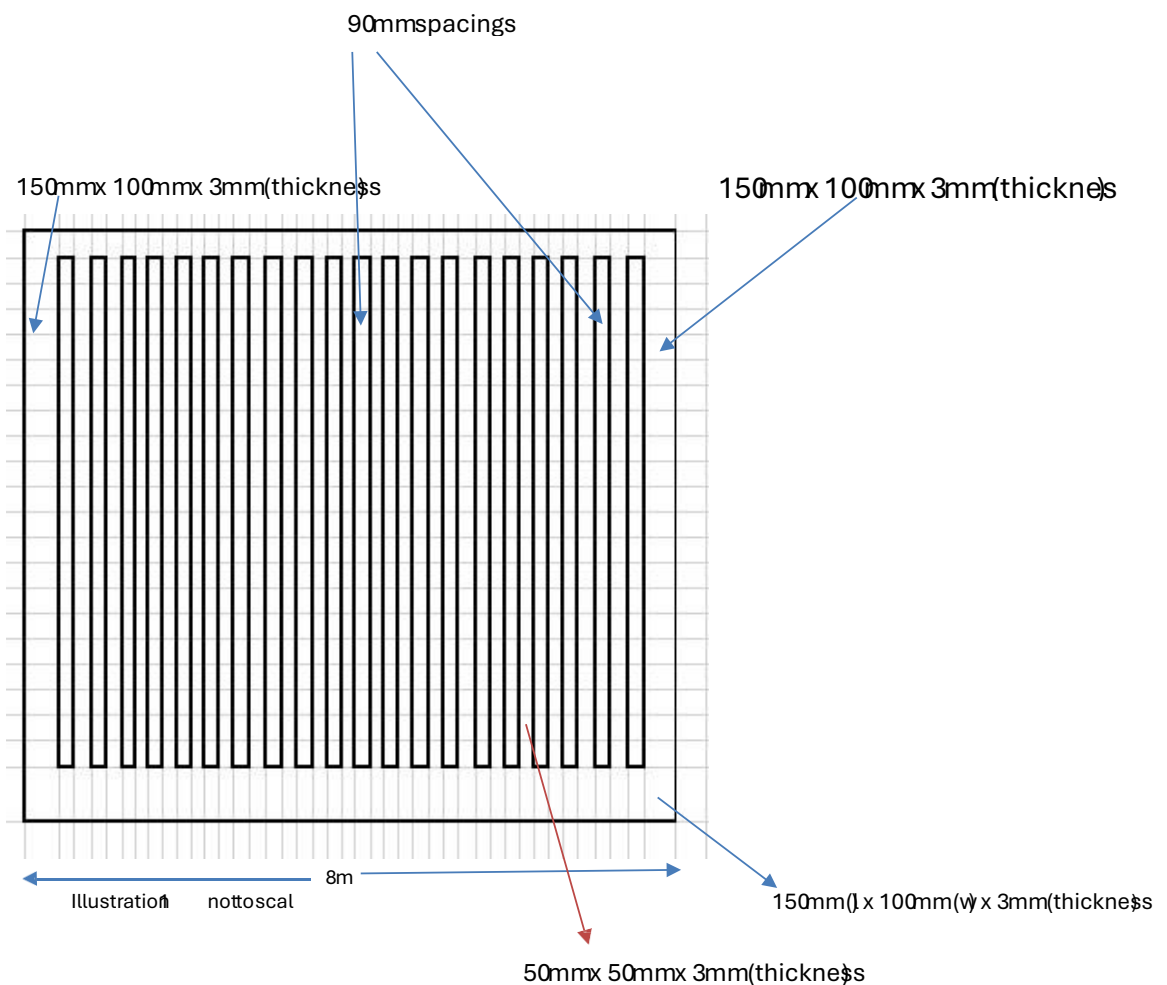
