TERMS OF REFERENCE FOR THE INSTALLATION OF AUTOMATIC FIRE SUPPRESSION SYSTEM, FIRE DETECTION SYSTEM AND ENVIRONMENTAL MONITORING SYSTEM IN THE CONTROL ROOM, DVR ROOM, SERVER ROOM AND PATCH ROOMS, INCLUDING MAINTENANCE FOR A PERIOD OF THREE YEARS (36 MONTHS).

1. INTRODUCTION

- ❖ The SADPMR wishes to appoint the service provider to install fire suppression, fire detection and environmental monitoring system in the control room, DVR room, server and the patch rooms, including maintenance for a period of three years (36) months.

2. PURPOSE

- ❖ The main goal is to install a fire suppression, fire detection and environmental monitoring system which will detect, alert and reduce the impact of fire in the early stage and bring the fire under control without disrupting the flow of business and the organisation's resources and also maintain the system.

3. OBJECTIVES AND SCOPE

- ❖ The project objective is to install a fire suppression, fire detection and environmental monitoring system to extinguish the fire in the control room, DVR room server, patch rooms and automatically shut down electricity if the suppression is triggered.
- ❖ The installation of fire suppression, fire detection and environmental monitoring system will greatly reduce the vulnerability of the equipment in the DVR room, control room, server room and patch rooms in the event of fire, as currently there is no fire suppression at the critical rooms. An undetected fire can completely destroy the entire rooms and its contents.

4. REQUIREMENTS

Below are the basic requirements for the SADPMR fire suppression, fire detection and environmental monitoring system. Supplier are welcomed to use the guideline for the proposal.

1. Server Room, Patch Rooms, Control room and DVR room Requirements

4.1.1 Server Room, Patch Rooms, Control room and DVR room Fire Detection

- ❖ Batteries 12V 7ah
- ❖ Optical smoke detectors
- ❖ Ionisation detector
- ❖ Detector basis
- ❖ Sounder beacon
- ❖ Gas Monitoring Units
- ❖ Break Glass Units
- ❖ Gas release relay
- ❖ Motorized Bell
- ❖ Fire Resistance Cable
- ❖ Conduit Boxes
- ❖ Conduit Saddle Galvanized
- ❖ Log book and holder
- ❖ Manual and Certificate
- ❖ Bell electronic
- ❖ Extinguishant release test interface
- ❖ Aircon shutdown approved
- ❖ Temperature sensor, programmable, with output relay

❖ Server and Patch Room Construction

- Conduits leading to and from server room must be sealed with fire retardant material
- No splices or connections of cables are to be allowed under the raised floor(must be done in a junction box). The number of junction boxes must be limited to the minimum.

❖ Communicator (SMS) Sundries

4.1.2 . Fire suppression Server room (Piped system due to floor void being too small)

- ❖ Gas cylinders (52ltr) complete with valve, gauges, actuator and mounting brackets
- ❖ HFC 227 gas
- ❖ Door signs
- ❖ Gas piping

4.2 Patch Rooms Fire Suppression (Modular)

- ❖ Gas cylinder (16ltr*3) complete with valves, gauges, actuator and mounting brackets.

4.3 Environmental Monitoring System

- ❖ The Environmental monitoring must be configured to communicate with the standby generator.
- ❖ The standby generator must not generate any electrical supply in the event of fire outbreak.

4.4 Gas Monitoring System

- ❖ The system should detect gas level and leakage.

5. Deliverables

5.1 Fire Detection Deliverables

- ❖ Should release gas to extinguish fire.

5.2 Fire Detection Deliverables

- ❖ Detection system should detect the heat/temperature increase and detect the smoke.

5.3 Environmental monitoring System

- ❖ Should the temperature increase in the DVR room, control room, server room and patch rooms, the environmental monitor system should send SMS notification to the custodian (delegated SADPMR officials) if there is any gas leakage or release.

6. COMPLETION DATE

- ❖ The expected duration for the supply, delivery and installation of the equipment is eight weeks from signing of the contract and then maintain the equipment for a period of thirty-six months (years).

7. COMPULSARY BRIEFING SESSION

- ❖ A compulsory information / briefing session will be held at the SADPMR office- in Bonaero Park as per SBD 1 form.

7.1 Bidder must be registered with relevant authority and provide such proof of certification.

NB Failure to submit the above requirements will automatically disqualify the bidder.

8. EVALUATION METHODOLOGY / CRITERIA

8.1. PHASE ONE EVALUATION

8.1.1 Company Experience

- ❖ Bidder must submit a minimum of three testimonials that they have performed similar project in the form of a signed reference letter on a letterhead of the respective companies with contact details confirming successful completion of installation of such projects.
- ❖ Bidder should have a minimum of three years' experience in the installation of fire

suppression, installation of fire detection and environmental monitoring system and provide certification of such proof.

NB Failure to submit the above requirements will automatically disqualify the bidder.

8.1.2 Technician requirement

- ❖ Technician's must have five experience (attach CV) in the installation of the suppression, installation of fire detection, environmental monitoring system.
- ❖ Technician's must be registered with the South African Qualification & Certification Committee for the Fire Industry (SAQCC Fire and Gas) and copy of the certificate must be submitted with proposal, failing which the bidder will be disqualified.

8.1.3 Project Plan / Methodology

- ❖ Service providers are required to have a clear project plan with final outputs and identified timeframe of the service to be rendered including maintenance.

8.1.4 Infrastructure

- ❖ It is expected of bidders to indicate that they're within Gauteng province on their proposal as bidders will be expected to maintain the equipment and respond timeously.
- ❖ Bidders are required to include their landline number, fax and email address on the proposal.
- ❖ Bidders are also required to submit copy of the physical address with their proposal.
