4. SCOPE OF WORK

The scope of work will include the purchase, collection, and removal of Scrap Ferrous metal (**Steel, Sub-Grade, CT's, VT's, Steel Cages, Porcelain, Rubber, Insulators, Isolators and line hardware**) on an "as and when" required basis within Eskom –Camden Power Station for a period of **Six (6) months** from date of signature.

The contract will be for a period of six (6) months for the disposal of ferrous and the contractor should take note that employer shall in terms of this clause: terminate the contract anytime should the need arise within the 6 (six) months period of this interim contract.
