- 1.2. **ALL BIDS MUST BE SUBMITTED ON THE OFFICIAL FORMS PROVIDED (NOT TO BE RE-TYPED) OR IN THE MANNER PRESCRIBED IN THE BID DOCUMENT.**
- 1.3. THIS BID IS SUBJECT TO THE PREFERENTIAL PROCUREMENT POLICY FRAMEWORK ACT, 2000 AND THE PREFERENTIAL PROCUREMENT REGULATIONS, THE GENERAL CONDITIONS OF CONTRACT (GCC) AND, IF APPLICABLE, ANY OTHER SPECIAL CONDITIONS OF CONTRACT.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

- the **80/20** system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the **90/10** system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 To be completed by the organ of state

- a) The applicable preference point system for this tender is the **90/10** preference point system.
- b) The **90/10** preference point system will be applicable in this tender. The lowest/ highest acceptable tender will be used to determine the accurate system once tenders are received.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 To be completed by the organ of state:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 OR 90/10 PREFERENCE POINT SYSTEMS

A maximum of 80 or 90 points is allocated for price on the following basis:

3.2. FORMULAE FOR DISPOSAL OR LEASING OF STATE ASSETS AND INCOME GENERATING PROCUREMENT

3.2.1. POINTS AWARDED FOR PRICE

A maximum of 80 or 90 points is allocated for price on the following basis:

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or

NOTES

The purpose of this document is to:

- (i) Draw special attention to certain general conditions applicable to government bids, contracts and orders; and
- (ii) To ensure that clients be familiar with regard to the rights and obligations of all parties involved in doing business with government.

In this document words in the singular also mean in the plural and vice versa and words in the masculine also mean in the feminine and neuter.

- . The General Conditions of Contract will form part of all bid documents and may not be amended.
- . Special Conditions of Contract (SCC) relevant to a specific Bid, should be compiled separately for every bid (if applicable) and will supplement the General Conditions of Contract. Whenever there is a conflict, the provisions in the SCC shall prevail.

General Conditions of Contract

1. Definitions

The following terms shall be interpreted as indicated:

- 1.1 **“Closing time”** means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 **“Contract”** means the written agreement entered into between the purchaser and the supplier, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 **“Contract price”** means the price payable to the supplier under the contract for the full and proper performance of his contractual obligations.
- 1.4 **“Corrupt practice”** means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 **“Countervailing duties”** are imposed in cases where an enterprise abroad is subsidised by its government and encouraged to market its products internationally.
- 1.6 **“Country of origin”** means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognised new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 **“Day”** means calendar day.
- 1.8 **“Delivery”** means delivery in compliance of the conditions of the contract or order.
- 1.9 **“Delivery ex stock”** means immediate delivery directly from stock actually on hand.
- 1.10 **“Delivery into consignees store or to his site”** means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the supplier bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
- 1.11 **“Dumping”** occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
- 1.12 **“Force majeure”** means an event beyond the control of the supplier and not involving the supplier's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
- 1.13 **“Fraudulent practice”** means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
- 1.14 **“GCC”** means the General Conditions of Contract.
- 1.15 **“Goods”** means all of the equipment, machinery, and/or other materials that the supplier is required to supply to the purchaser under the contract.
- 1.16 **“Imported content”** means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the supplier or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
- 1.17 **“Local content”** means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
- 1.18 **“Manufacture”** means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
- 1.19 **“Order”** means an official written order issued for the supply of goods or works or the rendering of a service.
- 1.20 **“Project site,”** where applicable, means the place indicated in bidding documents.
- 1.21 **“Purchaser”** means the organization purchasing the goods.
- 1.22 **“Republic”** means the Republic of South Africa.

1. PURPOSE

- 1.1. The purpose of this Request for Bids (RFB) is to solicit bids from potential bidder(s) which is a company with a specialist Ophthalmologist or a group of Ophthalmologist for the provision of Ophthalmology Services in various hospitals of the Limpopo Department of Health. This RFB document details and incorporates, as far as possible, the tasks and responsibilities of the potential bidder(s) required by Department for provision of Ophthalmology services to Limpopo Department of Health for a period of 36 months as and when required.

2. BACKGROUND

- 2.1. The mandate of the Limpopo Department of Health is to improve the health status of the people of Limpopo Province through the provision of health care services.
- 2.2. The Department is committed to improving life expectancy of the people of Limpopo.
- 2.3. The department is currently burdened with backlog across all disciplines with Ophthalmology backlog being the lead where vast number of Limpopo citizens are diagnosed with cataract that requires surgical intervention for removal as cataract may result to blindness if left untreated.
- 2.4. The National Department of Health has provided funding through National Health Insurance (NHI) grant to enable universal access to health care and Limpopo Department of Health wishes to accredit independent Ophthalmologists to manage and eradicate ophthalmology related backlogs such as cataract, glaucoma, squints and diabetic retinopathy and prevent anticipated progressive risk of blindness.

3. SCOPE OF WORK

- 3.1. The accredited service provider/s shall be able to provide ophthalmology services at designated Department's health facilities on days agreed upon by both parties.
- 3.2. The service provider/s shall submit quotation for rendering such services indicating the cost for rendering such services excluding surgical supplies.
- 3.3. The service provider/s shall provide own Anaesthetist or Medical Officer with Diploma in Anaesthesia (DA).
- 3.4. The service provider/s shall conduct proper work out (assessment and preparation) on patients to be operated upon at the designated health facilities.
- 3.5. The service provider shall keep a clear and detailed record of operation conducted on patients' medical records.
- 3.6. The service provider/s shall submit invoices timeously after operating on the patients with relevant clinical documentation (signed request list from the department, complete and accurate medical record detailing personnel involved in the operation).
- 3.7. The department shall provide operating theatre facilities, nursing personnel and surgical supplies.

4. KEY ASPECTS OF THE BID PROPOSAL

Bidders must take note of the following fundamental aspects before submission of their bid proposals:

- 4.1. The successful bidder will be bound by Government Legislative Framework i.e. the General Conditions of Contract and the Special Conditions of Contract (SCC), which will form part of the signed contract with the successful bidder. However, LDoH reserves the right to include or waive any condition in the signed contract.
- 4.2. The signed contract, which is inclusive of the GCC, SCC and Technical Specification shall be signed within seven (7) days after the acceptance of award of the bid.
- 4.3. LDoH reserves the right to –
 - 4.3.1. Negotiate the conditions, or
 - 4.3.2. Automatically disqualify a bidder for not accepting these conditions
 - 4.3.3. In the event that the bidder qualifies the proposal with own conditions and does not specifically withdraw such own conditions when requested upon to do so; LDoH shall disqualify the bid.
- 4.4. **Bidders must take note of the following fundamental aspects before submission of their bid proposals:**
 - 4.4.1. Bidders must submit their bids on the stipulated closing date and time. Late bids will not be accepted.

- 4.4.2. The SLA which is regarded as a performance agreement by the LDoH shall be negotiated with the end-user and signed off 30 days after signing of the contract with the Accounting Officer.
- 4.4.3. In order to evaluate and adjudicate bid effectively, it is imperative that bidders submit responsive bids. To ensure a responsive bid it is imperative to comply with all conditions pertaining to terms of reference.
- 4.4.4. Each bidder must attach all applicable documents in support of its bid in accordance with the requirements set out in this bid as well as any other relevant materials, photographs and/or attachments.
- 4.4.5. The department reserves the right to verify any information supplied by the bidder and should the information be found to be false or incorrect, the department will disqualify the bid and may further exercise any of the remedies available to it.
- 4.4.6. Each bid, once submitted, constitutes a binding and irrevocable offer to provide the services on the terms set out in the bid, which offer cannot be amended after its date of submission except for arithmetic errors.
- 4.4.7. The department reserves the right to invite any bidder for a formal presentation during the evaluation. A bidder should be prepared to do so at a venue that is convenient to the LDoH. All costs involved in the presentation or demonstration shall be borne by the bidder.
- 4.4.8. The department may, for any reason and at any time during the selection process, request any bidder to supply further information and/or documentation.

5. BID AWARD AND CONTRACT CONDITIONS

- 5.1. Bidders must submit their bid in line with the bid specification. Failure to comply shall invalidate the bid.
- 5.2. Bidders shall be notified about the decision of the Department by means of publication in the Provincial Tender Bulletin, Departmental website and E-tender portal.
- 5.3. The successful bidder/s must provide their own ophthalmologist and Anaesthetist or medical officer with Diploma in Anaesthesia (DA).
- 5.4. The bidder/s or employees of the bidding companies must not be employees of the Limpopo Department of Health.
- 5.5. A signed list of booked patients and actual list of operated patients to accompany an invoice.
- 5.6. A detailed record of the procedure performed shall be kept in patients' medical records and submitted/retained in the treating health facility.
- 5.7. The accredited service provider (Ophthalmologist) must render post – operative reviews/care up to 4 weeks including managing identified complications.
- 5.8. Bidders to take note that that the department shall complete the process of evaluation and awards in a period of 365 days.

6. THE BID ACCREDITATION AWARD STRATEGY

- 6.1. The department reserves the right to accredit the bid to one or more service providers, wholly or in part or not to award.
- 6.2. The accreditation shall be allocated based on bidders having complied with the mandatory and administrative bid requirements. It is imperative that bidders outline their capacity (how many operations can be done per day).
- 6.3. A price offers to be given to bidders that complied with the mandatory and administrative bid requirements for the accreditation based on market research.

7. RISK MANAGEMENT ON PRICING AND AWARDING

- 7.1. The department shall conduct market research to determine if preferred bidder did not underquote or overcharge their offer.
- 7.2. Price offer will be made to successful bidders where there is variation in quoted prices and market research.
- 7.3. All prices charged must be inclusive of business overheads, applicable taxes, and VAT. **NB: Successful bidders who are not registered for VAT at the time of bidding must register as required by law within 30 days after award.**

8. VALIDITY PERIOD OF THE BID

- 8.1. Bidders to take note that the bid shall be valid for the period of **365 days** and the validity period may be extended if necessary.

9. PRICE ADJUSTMENTS (CONSUMER PRICE INDEX)

- 9.1. Bidders must take note that prices shall be firm for the first twelve months of the contract, thereafter a CPI price adjustment shall be applicable annually if necessary.
