1. BACKGROUND OF THE PROJECT

The Golden Shield Heritage Awards is an annual project of the National Heritage Council of South Africa, an agency of the Department of Sport, Arts and Culture. The NHC will be hosting the Awards in Western Cape province. The Golden Shield Heritage Awards seek to recognise all those who have contributed to the preservation, protection and the promotion of South African heritage. The annual heritage awards will be hosted on 16 September 2024 in Cape Town.

2. PRODUCTS AND SERVICES REQUIRED

The NHC requires quotation to hire a DJ, cultural performance groups, performing artist-main act, Marimba and MC. Considering the nature of the Awards and the diverse group of people to be invited, the genre of music should cater for all. The awards are of the national significance and meant to promote our cultural heritage.

The NHC wishes to appoint a suitable experienced event co-ordinator that will obtain the relevant artists and DJ, who will be responsible to ensure that these artists are coordinated on the day of the event as per the event programme that will be discussed and agreed with the service provider upon award of the quotation. The event coordinator needs to understand the Heritage environment are in line with the theme of the event. The service provider will need to ensure that all costs are included and ensure that, where applicable, provision is made for their transportation and/or accommodation to and from the event.

Should the coordinator encounter a challenge after award and an artist, the DJ, MCs or any other performer are no longer available, it will be the responsibility of the coordinator to secure a replacement at no additional cost to the NHC. The NHC must be informed in advance of the replacement.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
