CONTEXT OF THIS PROCUREMENT NEED

iThemba LABS seeks to appoint a reputable Service Provider as required by National Treasury Regulations (NTRs) and Public Financial Management Act (PFMA) through an open and competitive process so that it can realise the benefits of the strategic sourcing.

In order to achieve further time and cost efficiency from economies of scale while ensuring outstanding quality of service, iThemba LABS wishes to enter into a 5-year agreement with competent service provider/s to provide customs clearance, freight forwarding and inland transportation services.

PART A – CONTRACT

DETAILED SPECIFICATIONS

DETAILED SPECIFICATIONS

The detailed technical specifications are as follows:

1. Services Required: -

1.1 Appointment of a panel of service provider/s to render freight forwarding and customs clearance services to iThemba LABS on an as and when required bases over a period of 5years.

1.2 The service providers must ensure that all work performed and/or equipment used on site complies with the Occupational Health and Safety Act (OHS Act No. 85 of 1993 and its Regulations). Scope of the required services:

2.1.1 Customs Clearance:

The service provider should have adequate knowledge of customs services and shall provide full clearing and forwarding services as and when requested by iThemba LABS). The scope of such services shall include the following:

a) Air Freight Imports

- Airfreight clearance on tax free basis;
- Customs knowledge in order to assist with rebate
- Provisional clearance pending perfection of documents (undertaking);
- Advice and assistance on prohibited commodities and guidelines in obtaining permits.
- Arrangement of pre-shipment inspections
- Arrangement of proper warehousing facilities and delivery to the final destinations;

b) Surface Imports and exports

- Surface imports and exports clearance, mostly containerized cargo;
- Conduct pre-shipment inspections
- Advice and assistance on prohibited commodities and guidelines in obtaining permits.
- Administrative payments at border points for all applicable expenses;
- Arrangement of proper warehousing facilities and delivery to the final destinations;

2.1.2 Deliverables

2.1.2.1 Freight Forwarding and Customs Clearance

The service provider shall ensure that their customs tariffs 'specialist shall manage customs vat, customs clearance of goods from point of entry for road surface, sea and air shipments. The Service Provider will also manage warehousing, cargo handling and freight forwarding services.

2.1.2.2 A detailed high-level execution plan by the service provider/s governing the day-to-day operations of the service being rendered which will include reporting, tracking and monitoring inclusive of the management of abnormal loads.

2.1.2.3 The Successful service provider/s shall provide the below services but not limited to:

- Provide its services to iThemba LABS on an as and when needed basis.
- Provide the necessary equipment, facilities, qualified personnel, expertise and other means necessary to perform the customs clearance, freight forwarding, transportation and related services in accordance with the best commercial practice.
- Perform necessary liaison and coordination in connection with customs clearance handling and general movement of the cargo and the equipment between the port authorities, customs representatives, port terminals and operation units.
- Ensure that the number of pieces, dimension of each piece, description of items, the packing and the gross weight and markings are in accordance with the information submitted.
- Give timely notice of any loss, damage or delay in respect of the goods as required.
- Prepay or arrange prepayment of, all applicable charges, from the point of delivery by the supplier as indicated in the Bill of Lading, Works/Purchase Order, Shipping instruction date of goods received, the number of pieces, goods volume and weight, description of the goods, invoice number, Suppliers invoice number, currency and amount, point of origin, delivery point/port of loading and port of discharge and submit / inform iThemba LABS as soon as shipping arrangements have been finalised;
- Carry out handling and storage/warehousing of consignments.
- Provide all necessary packaging where required.
- Secure specialised vehicles for transporting oversized cargo, hazardous material as per cargo requirements; cargos may comprise of raw materials, consumables, spares, accessories, tools, Capital Goods, Software etc. Some of the materials may be classified as hazardous, perishable, dangerous, corrosive or photo sensitive and may require careful handling/special storage and also warrant special arrangements for road/air transportation in consultation with supplier.
- Be responsible for damage to/and loss of cargo while in transit or while in storage under the custody of the service provider/s, the liability shall be the service provider/s sole responsibility
- In the event the Bidder provides the services through its agents or affiliates, all services provided by such

agents and affiliates of the Bidder/s shall be deemed to have been provided by the Bidder, and the Bidder shall remain responsible for the actions of its agents and affiliates performing the work.

- The customs formalities to be completed for cross-border traffic and must be dealt with punctually and be treated according to instructions by the service provider/s.
- The bidder/s is required to demonstrate the ability to handle comprehensive freight forwarding, customs clearing, exports, imports, logistics services and logistics consulting for iThemba LABS projects, capital purchases and operational material in and from all countries of supply.
- The bidder may be required to demonstrate capability and capacity of handling the transportation of containerized, break bulk, fragile and abnormal loads as designated by iThemba LABS from time to time, to the nominated delivery destinations in the Republic of South Africa or elsewhere with regards to exports. The cargo to be transported could be break bulk, containerized, fragile and staged projects.
- Bidders will be required to demonstrate packing, freight handling, forwarding, cargo storage, customs clearance, customs inspections and other related services that apply to shipments originating from, consigned to, routed through, and or moved from country of origin to its destination; and
- Bidders will be required to provide resources necessary to accomplish all work as required by iThemba LABS.
- The service provider to ensure that all shipments of iThemba labs are allocated to a designated account manager for tracking purposes, this would enable shipment progress and monitoring by the customer.
- Bidders also need to indicate the ability to manage bonded warehousing.

2.1.2.4 Expected Types of Consignments

The main commodities to be customs cleared, warehoused and transported are, but not be limited to, the following:

- Laboratory equipment and medical supplies
- Various machinery/construction equipment
- Donated equipment and materials as per collaboration agreement
- Soil samples for research and analysis purposes
- Re-importation of research equipment after repairs have been done by manufacturer under

warranty

- Temporary/ loaned research equipment for experiment purposes
- Educational and printed materials
- Office supplies and equipment
- IT equipment, telecommunications equipment, consumables etc
- Dangerous Goods
- Sensitive Cargo
- Abnormal Cargo
- Movement of dry ice
- Other items that are not listed above but are necessary for the activities of iThemba LABS

2.1.3 Business Case:

A substantial part of the maintenance parts required during Shutdowns are ordered from abroad. Various other parts and equipment which includes amongst others: i) new and donated equipment, ii) loan equipment, and iii) various parts and materials used by the different user departments and technical support departments are mostly ordered from abroad and require clearing through South African Customs.

The different departments also have international research collaborations with various institutions and from time to time export of certain parts, materials and research equipment require Customs Forwarding clearance. On occasion the need arises for the return of defective goods under customs supervision clearance.

End-User:

Various Departments within iThemba LABS.

When:

We used an estimated total value of R10 Million per annum with an average of five (5) imports and one (1) export per month. The values and numbers provided above are for evaluation purposes and should not be seen as a guarantee as the actual figures. This contract will be on as and when required.

2.1.4 Standards and Codes

- 1.4. Provide proof or evidence of a quality management system i.e. Quality Policy and/or ISO 9001:2015 accreditation.
- 1.5. Provide proof of an existing Logistics, Freight Forwarding and Customs Clearing, services footprint – from which proof /evidence must be provided i.e. an official letter.
- 1.6. Provide proof of DA185 accredited registered / licensed customs clearing agents.
- 1.7. Provide CV of your customs tariffs specialist and customs clearing agent with a minimum of five (5) years' experience.
- 1.8. Preference may be given to a bidder who have a South African Association of Freight Forwarders or any related professional body for freight forwarders.
- 1.9. Public Liability Certificate

Implementation, hand over, and product management

The appointed bidder provides the delivery management as specified in the detailed specification / terms of reference. iThemba LABS will issue purchase orders as a project control tool "for each batch/lot being despatched and will monitor the execution of the delivery schedule until the purchase order requirements are received on site.

Incidental Services to the subject matter of this contract (General Condition of Contract Clause No: 13)

In the event of requiring such incidental services, it is only valid if confirmed through the issue of a written purchase order that specifies, where applicable, quality, quantity, description, unit price, and delivery date.

Performance Verification (General Condition of Contract Clause No: 8)

The iThemba LABS appointed project manager verifies the performance of this contract with reference to the required requirements and any other element specified in this contract:

The appointed bidder will render services as per specifications under this contract.

Both parties agree on quantity, unit cost, and total value on the same signed document.

Contract Due Diligence during the contract period

iThemba LABS has the right to conduct supply chain due diligence. The iThemba LABS Project Team have the right to conduct site visits and inspections at any given time during the contract period.

Communication (General Condition of Contract Clause No: 31)

The appointed bidder communicates in writing through regular mail, physical delivery, or email. The appointed bidder states the contract number and purchase order number on communication documentation. The contract bidder does not act upon any communication without the contract number or must verify such communication with the iThemba LABS project manager prior to acting upon it.

Performance Security (General Condition of Contract Clause No: 7)

An acceptable financial performance bond is required where iThemba LABS pays an upfront deposit in excess of R 1 million to the same value as any such upfront deposit. No other performance security is required.

Packing (General Condition of Contract Clause No: 9)

Components (where applicable) must be packaged such that they prevent damage during transportation and storage.

Payment (General Condition of Contract Clause No: 16)

Payment terms are within 30 days of receipt of an invoice issued following successful rendering of services and earlier where the invoices are accompanied by signed iThemba LABS delivery validation documents including proof of performance stating acceptance of quantity, acceptance to specification, and unit pricing in agreement with the contract and any purchase orders issued in terms of the contract.

It is in the interests of the appointed bidder to adhere to these to receive prompt payment. Any losses incurred through exchange rate variations or interest charged on late payment will be charged to the appointed bidder where these costs arose from non-adherence to the above.

Prices (General Condition of Contract Clause No: 17)

<u>Exchange rate prices</u> – Where the supplied requirements are from overseas, the appointed bidder will state the portion and currency payable overseas separating local costs. iThemba LABS will only consider exchange rate variations on the identified foreign price component. The rate variation is the difference between the current exchange rate and the exchange rate ruling at the date of signing the SBD 7.1. Exchange rates are obtained from ABSA or for the www.xe.com website. iThemba LABS will verify the submitted exchange rate variation and enter into negotiation with the appointed bidder on the agreed variation. |

the cost of the appointed bidder. The defaulting appointed bidder is obliged to settle the damages/additional costs that iThemba LABS has incurred as result of the non-performance of the appointed bidder.

PERFORMANCE LEVEL (General Condition of Contract Clause No: 22)

If the appointed bidder fails to meet any performance level:

- a) Both iThemba LABS and the appointed bidder shall jointly investigate and report on the root causes of the performance level failure;
- b) Promptly correct the failure and begin meeting the set performance levels;
- c) Advise iThemba LABS as to the extent requested by iThemba LABS of the status of remedial efforts being undertaken with respect to such performance level failure; and
- d) Take preventive measures to prevent the recurrence of the performance level failure.
- e) In the event of the non-performance as per the agreed contract, iThemba LABS will appoint an alternative provider at the cost of the appointed bidder. The defaulting appointed bidder is obliged to settle the damages/additional costs that iThemba LABS has incurred as result of the non-performance of the appointed bidder.
