**TERMS OF REFERENCE FOR THE APPOINTMENT OF A SERVICE PROVIDER TO  
PROVIDE SERVICES TO CHANGE SAFES CODES AND COMBINATIONS FOR THE  
SOUTH AFRICAN DIAMOND AND PRECIOUS METALS REGULATOR (SADPMR)**

**1. BACKGROUND**

The South African Diamond and Precious Metals Regulator (SADPMR) is a state-owned entity which is based in Gauteng Industrial Development Zone (GIDZ) in Bonaero Park, Kempton Park. The SADPMR would like to enter into a two-year (2) contract with a reputable company that will be able to provide services to change safes codes and a combination for 2 safes on quarterly basis for a period of two years. The appointed service provider will be providing these services for the Diamond Exchange and Export Centre (DEEC) which is a division within the SADPMR.

**2. SCOPE OF SERVICE**

**Change safe codes and combinations**

- Provide services to change safes codes and a combination on quarterly basis.
- To service the safes in case of emergencies / being unable to unlock.

**3. PROJECT OUTPUT AND/OUTCOMES**

- The SADPMR would like to enter into a two-year (2) contract with a reputable company that will be able to provide services to change safes codes and a combination for 2 safes on quarterly for a period of two years.

**4. REPORTING REQUIREMENT**

- The service provider will report to DEEC.

## **5. DURATION**

- The expected duration of the service to change safes codes and a combination for 2 safes on quarterly basis is two (2) years commencing 01 September 2022.

## **6. EVALUATION METHODOLOGY/CRITERIA**

### **6.1 Phase One Evaluations**

#### **6.1.1 Company Requirement**

- Bidders are required to submit a copy of an accreditation / registration certificate /s with the approved Authority and PSIRA compliance.

**N.B. Failure to provide proof of registration with a professional body will result in a bidder being disqualified for further evaluation.**

#### **6.1.2 Company Experience**

- Bidders should have a minimum of 5 (5) years' experience in the safe sector and must provide company profile.
- Provide/submit a minimum of 3 signed contactable reference letters on the letterhead of the respective companies indicating that similar services/projects were provided.
- 1 reference letter should not be less than 5 years indicating similar services/projects were provided by the supplier.

#### **6.1.3 Project Plan / Methodology**

- Service providers are required to provide a comprehensive project plan indicating how the servicing of the safes will be managed.
- Provide a detailed assurance that SADPMR will be adequately be serviced at all times even during emergencies of safes having being jammed.

#### **6.1.3 Infrastructure**

- Bidders are required to indicate basic facilities, which include a telephone line, functional company website and email.

- Bidders are required to provide proof of physical address e.g. municipal bill for rates and taxes or water and Lights statement or a lease agreement.
- A site visit will not be conducted with the short-listed bidders.

#### **6.2.1 Project Cost**

- Provide fixed price quotation for the duration of the contract.
- Cost must be inclusive all applicable taxes and quoted in South African Rand.
