- Train in emergency vehicle handling and advanced vehicle control techniques.

5. DURATION

The course must offer a minimum of 8–16 contact hours, depending on the training intensity and facility capacity.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS
