TERMS AND CONDITIONS OF REQUEST FOR QUOTATION (RFQ)

1. Broadband Infraco standard conditions of purchase shall apply.
2. No services must be rendered or goods delivered before an official Broadband Infraco Purchase Order form has been received.
3. Late and incomplete submissions will not be accepted.
4. Any bidder who has reasons to believe that the RFQ specification is based on a specific brand must inform Broadband Infraco before RFQ closing date.
5. Where applicable, Work will be carried out in terms of the OHSA and regulations and therefore it is important for the bidders to include OHSA compliance costs (i.e safety file for the recommended bidder will be approved by Broadband Infraco).
6. **Bidder is required to submit copy of Tax Clearance Certificate and verification information (PIN) to be used by Broadband Infraco to validate the copy on the SARS website for all price quotations exceeding the value of R30 000 (VAT included). Failure to submit the copy of valid Tax Clearance Certificate and verification information will result in the invalidation of this RFQ. It is the responsibility of the bidder to ensure that Broadband Infraco is in possession of the bidder's valid Tax Clearance certificate. The onus is on the bidder to ensure that Broadband Infraco receives a valid Tax Certificate as soon as the validity of the said certificate expires.**
7. Bidders must attach valid BBBEE certificate, correct affidavit or valid exemption letters with the bid. **Copies must be certified.**
8. Bidders are required to complete Annexure A for all price quotations exceeding the value of R30 000 (VAT included).
9. This RFQ will be evaluated in terms of the 80/20 preference point system prescribed by the Preferential Procurement Regulations, 2017
10. All prices must be quoted in South African Rand (ZAR) and the foreign currency amount applicable must be stated. The bidder must indicate **clearly** which portion of the quoted price is linked to the exchange rate. The cost of installation, delivery, and **other** charges must be included in the total price quoted.
11. It is within Broadband Infraco's prerogative to award this bid in part/s or whole to one or more than one service provider based on the pricing and other technical consideration within the ambits of the law.
12. Broadband Infraco will only commence payment processes after fulfilment of the conditions contained in the contract and/ or on receipt of an invoice from the service provider and after such has been approved by the client division as representing the services received.

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

 - (d) recommend that the tenderer or contractor, its shareholders and directors, or only the shareholders and directors who acted on a fraudulent basis, be restricted from obtaining business from any organ of state for a period not exceeding 10 years, after the *audi alteram partem* (hear the other side) rule has been applied; and
 - (e) forward the matter for criminal prosecution, if deemed necessary.

TERMS OF REFERENCE

1. BACKGROUND

As part of a broader project to relocate the old NOC & WACS office space at Woodmead to Sentech, Broadband Infraco needs to appoint a company to develop a comprehensive design, equipment procurement, renovate, install and hand-over the building back to Broadband Infraco. Although the NOC & WACS staff are still working from home, it is critical that a conducive work space suitable for a 24/7 work setup is established both for the staff and clients serviced.

2 Motivation:

The establishment of the new NOC office space is very critical not only to the business but staff. Yes covid is still present but precautions are in place to allow staff to work in-person with each other. Creating a conducive place allows others who are challenged at home when it comes to data network, electricity supply and ergonomically suitable furniture in order to be productive.

3. Scope of work/supply

Appointed service provider must provide professional services in respect of the 102m² open space. The services will explore the following section of the space but not limited to:

3.1 Office Design

- ▶ Design the floor plan inclusive of all amenities and facilities (furniture, lighting, electrical points, UPS, HVAC, etc).
- ▶ Update all existing floor, fire and evacuation layouts including installation drawing and schedules. These must be aligned with required statutory requirements of the Occupational Health and Safety Standards. (OHS Act).

3.2 Electrical

- ▶ Based on the desk, printing area, UPS, lighting, etc layout. Design must consider power supply points, light fittings and reticulation in general.
- ▶ The design, should seek to optimise on energy saving and efficiency.

- ▶ Design must recommend the correct ambient lighting controlled with illuminance levels.

3.3 Construction

- ▶ Consider any repairs required on the walls, ceiling, floors and propose such works.
- ▶ In conjunction with our marketing team, provide guidance on painting that aligns to our branding.

3.4 HVAC

- ▶ Consider the layout based on the suggested ± 48000 BTU aircon sizes and location in order to service the entire area (for both staff and equipment). The system can be two (2) ceiling or hide away (4-6) units.

3.5 General

- ▶ The design must comply with the OSH Act and national building regulations and standards of South Africa.
- ▶ Provide a professional opinion with regards to the budget to implement the above-mentioned scope.
- ▶ Provide professional drawings (auto CAD or other approved software) and also provide these in a PDF format.

3.6 Renovation Work

Convert the above designs and plans into construction work including.

- ▶ Project managing the different activities of the renovation.
- ▶ Allocate skilled labour for the renovation.
- ▶ Procure all require equipment and material to achieve the above requirements.
- ▶ Make provision and/or recommendation on further areas that may be required and critical.

The service provider must consult with the electrical, structural, construction, mechanical, HVAC specialist amongst other in order to understand the Broadband Infraco general requirements and address the above-mentioned scope. These professionals reside inside and outside the Broadband Infraco and Sentech.

4 Additional Requirements

Bidders must meet the following requirements

- Professional registration certificate with a relevant association / board in South African (South African Council for Architectural Profession - SACAP)
- Compliance with statutory requirement including the National Building Regulations & Standards, OHS Act and fire legislations, etc.
- Since this will be a capital project done in the Sentech building which is a National Key Point, the service provider and its staff will be required to meet Sentech and Broadband Infracore supply chain management & SHEQ requirements including those that State Owned Companies must subscribe to.
