THE BIDDING SELECTION PROCESS

Phase 1 – Compliance to minimum administrative documents

Bidders warrant that their proposal document has, as a minimum, the specified documents required for evaluating their proposals as set out in the Returnable Document List.

Bidders making the minimum evaluation score will pass to the mandatory evaluation stage.

Phase 2 – Compliance with mandatory requirements

In this phase bid responses are verified against the set of mandatory requirements. Bidders who fail to comply with the requirements may not proceed to the next phase of evaluation, phase 3.

Phase 3 – Price Evaluation

Basis of competition:

SANParks compares each bidder's pricing proposal on an equal and fair comparison basis that is equitable to all bidders taking into account all aspects of the bids pricing requirements.

SANParks conducts fair market-related pricing tests to arrive at an opinion of reasonableness of the bid price offered.

Due diligence tests for reasonableness of price:

SANParks conducts fair market-related pricing tests to arrive at an opinion of reasonableness of the bid price offered. Where these tests reflect defective pricing or pricing outside of the fair market-related price range, the evaluators will recommend price negotiation with the winning bidder to bring the price within the fair market-related price range as tested.

Where the winning bidder does not want to participate in the price negotiation or provide a fair market-related price, SANParks reserves the right to cancel the award and commences price negotiations with the second bidder.

Ranking of the bidders pricing:

SANParks ranks the qualifying bids on price in the following manner:

Price and preference – for bids qualifying for this stage, the bidder with the highest price and preference points will be selected in terms of PPPFA Circular No.01 of 2021-2022, where the formula for revenue generating projects will be used.

Award recommendation:

Due to the nature of the bid being for culling services and being an income generating bid, SANParks nominates the bidders on the highest price and preference points scored, in terms of PPPFA Circular No.01 of 2021-2022.

SANParks reserves the right to award to more than one service provider. Therefore phase 3 evaluation will be conducted per park. SANParks will award to one service provider per park. The total bid price is for completeness purposes only.

BID PROCEDURE CONDITIONS:

Counter Conditions

SANParks draws bidders' attention that amendments to any of the Bid Conditions or setting of counter conditions by bidders will result in the invalidation of such bids.

Two Envelope System Required for Technical and Pricing

The objective is to evaluate the Proposals Section without reference to the Price Section ensuring both sections are evaluated fairly and unbiased.

The first envelope (first secured PDF) holds all documents excluding the SBD 3 (price summary schedule) and detailed supporting pricing documentation. The second envelope (second secured PDF) holds the SBD 3 and the detailed supporting pricing documentation. An outer envelope encloses both envelopes.

SANParks only opens the technical proposal at the evaluation stage and only opens the pricing proposal for those bidders who meet the predefined threshold at the proposal evaluation.

Response Preparation Costs

SANParks is NOT liable for any costs incurred by a bidder in the process of responding to this Bid Invitation, including on-site presentations.

Cancellation Prior To Awarding

SANParks reserves the right to withdraw and cancel the Bid Invitation prior to making an award. The cancellation grounds include insufficient funds, where the award price is outside of the objective determined fair market-related price range (in terms of the Preferential Procurement Policy Framework Act 2017 Regulations), or any process impropriety.

Collusion, Fraud And Corruption

Any effort by Bidder/s to influence evaluation, comparisons, or award decisions in any manner will result in the rejection and disqualification of the bidder concerned.

Fronting

SANParks, in ensuring that bidders conduct themselves in an honest manner will, as part of the bid evaluation processes where applicable, conduct or initiate the necessary enquiries/investigations to determine the accuracy of the representation made in the bid documents. Conditions include:

- No specific animals may be selected - the cull MUST be non-selective (randomly and aim to achieve a naturally occurring sex ratio removal of listed species).
- Specific animals pointed out by the Park Manager or any other staff member may not be culled.
- The successful service provider WILL be accountable for any and all animals wounded or injured during the cull.
- The successful service provider WILL be responsible for the animals as soon as the capture process begins, and mortalities during the ensuing chase are thus to be paid for as for culled animals.
- SANParks reserves the right to euthanize any wounded animal. Should SANParks determine that an injured animal is suffering, it retains the right to euthanize such an animal on the tenderer's account. The carcass remains the property of the service provider and the price for the animal remains unchanged.
- Should any irregularities be witnessed by SANParks during the cull, SANParks retains the right to act against the service provider and to terminate the culling by the service provider.
- The red offal (Heart, Lungs, Spleen, Liver and Kidneys form part of the carcass, but is not weighed.
- Both the carcass and the red offal should be tagged with the same identifying number in order for the State Veterinarian at the registered abattoir to do the final

post mortem meat inspection and to declare the specific carcass suitable for human consumption.

- All reasonable precautions **MUST** be taken by the successful service provider to avoid the disturbance of non-target animals and veld fires.
- The successful service provider may not sub-contract the cull without prior written agreement with SANParks.
- The service provider will be subjected to SANParks legal audit prior and during the commencement of operations and will be subjected to approval by the Environmental Crime Investigation (ECI) services after security audit.
- The service provider must ensure that the harvested meat is exposed through a registered abattoir!
- Being in possession or the consumption of alcohol during culling operations or the bringing of any alcohol to any part of the culling operations is strictly prohibited.
- All refuse generated by culling operations must be removed from the park by the operator – this includes ammunition shells, domestic waste, etc.....Under no circumstances should any of the above items be disposed of with the entrails (should the latter be disposed of in the veld).
- An attendance register must be kept on a daily basis of all participants in the culling operations – hunters, skinners, SANParks staff. The names thereon must be correlated by the manager/operator (culling operations) and the designated SANParks official.
- No 'disguised trophy hunting' is permitted – All culling activities must conform strictly to standard culling operations. No trophy hunting related activities will be permitted – caping, the taking of specific photographs, posing with carcasses, etc....

Logistics include:

- The handling, storing and transport of the carcasses are for the service provider's account.
- The service provider **WILL** be responsible for all logistical arrangements.
- Successful service provider **MUST** provide all firearms, ammunition, silencers and proof of calibrated scale equipment and vehicles for the culling.
- The successful service provider **MUST** supply a list of all equipment, vehicles and a list of personnel to the Park / Conservation Manager / Section Ranger before the cull commences. The following points needs to be considered:
 - Where harvesting takes place from vehicles a maximum of 6 culling vehicles will be allowed with a maximum of 6 cullers per Reserve/Park."

- Where helicopter culling takes place a maximum of 1 helicopter and 2 helicopter cullers per park/reserve with a maximum of 6 collection vehicles.”
- All harvesters, staff and vehicles will be registered once with the Reserve manager prior to commencing with the cull.”
- The same vehicles, cullers and staff registered will be used for duration of cull. No rotation of cullers, staff or vehicles will be allowed.”
- The service provider **MUST** make their own arrangements for the processing of the carcasses. Slaughter facilities are not available on site, but a central point with running water will be provided.
- Only light delivery vehicles (LDVs) **WILL** be allowed into the veld and off road driving must be within reason and will only be permitted with the approval of the Park / Conservation Manager / Section Ranger.
- All generated waste, inclusive of animal parts, **WILL** be removed and disposed of from the National Park by the successful service provider or special arrangements must be discussed with park management.
- The liability of the **aircraft, pilot and crew while** operating in the National Parks **WILL** be the responsibility of the service provider.
- SANParks shall not be held accountable or responsible for any claim, loss or damage whatsoever arising subsequent to the operation of the helicopter, and the service provider hereby indemnifies SANParks and holds it harmless against any claim in this regard.
- All hired equipment necessary to set up required infrastructure is for the account of the service provider.
- The successful service provider **MUST** acquire and **provide proof** of a combined 3rd Party and Public Liability Insurance Policy (Minimum of R 5 000 000.00 (Five million Rand) per incident).

Firearms include:

- The service provider must comply with the applicable Firearms Control Act.
- The Corporate Manager: Firearms Management (DFO) will issue an **Authorisation to conduct duties with a private firearm within SANParks** to the applicant to authorise him/her to conduct only official work with the private firearm within the National Park, approved by the Park Manager;
- No private individual that are not part of the culling team are allowed to cull any game in the National Park
- The successful service provider must have a valid service level agreement in place with SANParks.

- The successful service provider must declare and receive approval, before the firearm is brought inside the National Park from the Park Manager of the specific National Park.
- The reason, purpose and time period that the private firearm will be utilized inside the National Park, must be motivated in the declaration application to the Park Manager.
- The following documents must be attached with the declaration application:
 - Copies of the valid license for the specific firearm;
 - Copies of the valid SAPS Competency Certificate for the specific firearm;

The successful service provider must ensure that he/she understands and adheres to the following:

- Ensure that the correct prescribed legal minimum calibre firearms are utilized for the specific purpose:
- The calibre must be suitable for the type of animal in the area for the specific purpose that the person will conduct duties (Must be prescribed in the contract);
- Ensure that the person bring along their own ammunition to utilize with their private firearm.
- All private firearms must be carried in a holster/holder/bag as prescribed by the Act (No firearms to be displayed/carried openly in public);
- The person must constrain to the approved policy and protocol regarding firearm management and control within SANParks;
- The private firearm must always be kept under his/her direct control;
- Good housekeeping principles must be adhered to – the service provider must as far as possible retrieve his/her empty cartridges that were used inside the National Park;
- SANParks is absolved from any liability relating to the loss of, or damage to the private firearm or any damage caused by use or misuse of the firearm;
- Compliance with all provisions of the Act pertaining to private firearms;
- Any person that possesses a private firearm or ammunition on SANParks premises and fails to comply with the above instructions, may be subjected to criminal and disciplinary action.
- Prior to the culling operations, the service provider must provide a list of names of all shooters/hunters that he intends using for the culling operations.
- Once the cull has commenced, no changes will be allowed to these names.

OCCUPATIONAL HEALTH AND SAFETY REGULATIONS AND PROCEDURES SHOULD BE ADHERED TO.

The purpose is to provide guidelines and stipulate measures to be taken in order to protect the health and safety of all persons and members of the public entering SANParks worksites or are exposed to SANParks work activities. The following aspects needs to be adhered to:

- 1. Provision of safe transport**
- 2. Conduct risk assessment on site**
- 3. Provide Personal Protective Equipment to all personnel involved.**
- 4. Comply with health safety work practices.**
- 5. Conduct briefing and debriefing sessions on operations.**
- 6. All tools and equipment used must comply with OHS regulations.**

Accommodation include:

- Accommodation inside the National Park is managed by the Park/Conservation Manager and accommodation arrangements must be made through him/her.
- It is advised that the service provider should visit the National Park beforehand to familiarize themselves with the terrain, access roads and distances from the closest towns.
- The cost of accommodation, if used, is for the account of the service provider and SANParks' standard tariffs will apply.
- Should accommodation not be available inside the National Park, the service provider may at its cost set up a camp if arranged with SANParks inside the National Park.
- Rental of any ablution facility or chemical toilets will be for the account of the service provide
- No informal accommodation will be allowed – camping informally in the veld, etc...
- If camping is required the SANParks responsible/designated person must approve the site of such camping and which activities are permitted at such sites – making of fires, cooking, erection of shelters, etc.

Permits include:

- The service provider **MUST** comply with all applicable legal provisions (Meat Safety Act, Act 40 of 2000, Firearms Control Act and Regulations (Act 60 of 2000) NEMPA and NEMBA).
- All regulations applicable to National Parks, **MUST** be strictly adhered to.

- Arrangements for any permits required is the responsibility of the successful service provider, and MUST be made timeously during normal office hours.
- Any other applicable legislation MUST also be adhered to, e.g. The Meat Safety Act, etc.
- All required permits and compliance with the Meat Hygiene Act and wildlife meat processing guidelines need to be adhered to.
- TOPS permits needs to be in place before culling of protected species in Mountain Zebra National Park and Camdeboo National Park can commence.

Payment include:

- The successful bidder hereby agrees to pay **100%** (One Hundred Percent Deposit) of the price referred in the pricing schedule for each park to SANParks by way of electronic transfer, without deduction or set off, and into a bank account nominated by SANParks, before or on the day of commencing with the culling operation.
- The successful bidder SHALL provide SANParks with adequate proof of the deposit payment before Culling in the national park can commence.
- The balance of the payment, as well as any other tariffs or other debt, must be settled within 30 days after receiving a valid invoice.
- **Bids for the culling must be given per kilogram carcass, minus 3% warm weight, skin intact, without head, hooves and intestines.**
- **Plains Zebra will be weighed into the truck with skin intact, head intact, hooves intact and without intestines, minus 10% warm weight, compensating for head and hooves.**
- The estimated average weight referred to in the pricing structure is for evaluation purposes only.
- The final weight will be confirmed by signing the removal certificate by both the service provider (representative) and a SANParks representative.
- Removal certificates MUST be completed and signed by representatives of both parties at the end of each day.
- Should the final calculated weight as well as the final number of animals differ from the number provided for in the pricing schedule SANParks and the service provider undertake to pay the difference within 30 days after receiving a valid invoice?

Period include:

- The Culling in Mountain Zebra NP must be completed before or on **31 March 2023**.
- The final cull date must be determined together with the park management and written confirmation should be provided.

RESPONSIBILITIES OF SANPARKS

- The service provider will be notified in writing of sub-standard services. SANParks reserves the right to terminate the contract should sub-standard services persist.
- To provide the tendering company with information that will assist in submitting the tender.
- To give the tendering company access to the different facilities, should they require to do site inspections.

RESPONSIBILITIES OF THE BIDDER

- Service providers are encourage to register with professional regulatory bodies such as Professional Culling Operators Association of SA (PCOASA) or GAME SA.
- Preference will be given to service providers who are registered with PCOASA or GAME SA.
- **No Alcohol** will be allowed in the National Parks by the Service Provider.
- Service provider to remove all general waste from the National Park.
- All workers will be required to wear service provider's corporate uniform & name tag.
- Services to be rendered according to accepted national cleaning standards and rendered against compliance to a check list to be provided per site upon awarding of the contract.
- Service provider to provide own protective clothing (PPE).
- Staff transport is at service provider's own cost.
- Police clearance for all staff must be available on request within 72 hours.
- Bidders are to provide a service delivery strategy, indicating their ability to deliver services within a reasonable timeframe from the date of receiving the letter of intent – Bidder to indicate their required lead-time per park requirement.
- Bidders must provide evidence of equipment capacity / infrastructure and a deployment plan for providing or delivering the required services.

MEETINGS AND/OR REPORTING

- The park manager or section ranger or a delegated official will be assigned to deal with the service provider per national park.
- Service provider(s) must familiarise themselves with the sites that need services in terms of geographical locations.
