

SECTION 2.2: MBD 3.1 PRICING SCHEDULE

NOTE: ONLY FIRM PRICES WILL BE ACCEPTED. NON-FIRM PRICES (INCLUDING PRICES SUBJECT TO RATES OF EXCHANGE VARIATIONS) WILL NOT BE CONSIDERED

PRICING SCHEDULE:

Pricing Instructions mean the criteria as set out below, read together with all Parts of this contract document, which it will be assumed in the contract that the bidder has taken into account when developing his prices.

- 2.1.1 The short descriptions and category number given in the pricing schedule below are brief descriptions used to identify the activities for which prices are required.
- 2.1.2 While it is entirely at the bidders's discretion as regards to the pricing schedule below, guideline tariffs of fees or indicative time based fee rates are gazetted annually, which are useful documents that will give bidder's some idea of industry norms against which they may compare their rates, sums, percentage fees and/or prices as applicable.
- 2.1.3 For the purpose of the pricing schedule, the following words shall have the meanings hereby assigned to them:
Price: All-inclusive price for the service.
- 2.1.4 A rate, sum, percentage fee and/or price as applicable, is to be entered against each item in the pricing schedule. An item against which no price is entered will be considered as a no offer and the bidder will not be evaluated.
- 2.1.5 The rates, sums, percentage fees and prices in the pricing schedule are to be fully inclusive prices described under the several items. Such prices and rates are to cover all costs and expenses that may be required in and for the execution of the work described, and shall cover the cost of all general risks, liabilities, and obligations set forth or implied in the Contract Data, as well as overhead charges and profit.
- 2.1.6 Where quantities are given in the pricing schedule, these are provisional and do not necessarily represent the actual amount of work to be done. The quantities of work accepted and certified for payment will be used for determining payments due and not the quantities given in the pricing schedule. In respect of time based services, the allocation of staff must be agreed with the employer before such services are rendered.
- 2.1.7 All rates, sum, percentage fees or prices (as applicable) quoted in the pricing schedule shall be final and binding and shall not be subject to any variation throughout the period of the contract, and will be seen as non-responsive.
- 2.1.8.1 The bid will be evaluated based on the all-inclusive price.
- 2.1.8.2 Pricing put in the normal standard narrative and then a schedule with the element of cost as set below:
- Initiation cost, if applicable (This includes all costs relating to the setup or transferring of the Toll-free number).
 - Monthly fee/cost.
 - Full price listing for each of the various branding / marketing options.
