# CERTIFICATE OF INDEPENDENT BID DETERMINATION

- 1 This Standard Bidding Document (SBD) must form part of all bids<sup>1</sup> invited.
- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe* se prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
  - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
  - cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.
- This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bid-rigging.
- In order to give effect to the above, the attached Certificate of Bid Determination (SBD 9) must be completed and submitted with the bid:

Bid rigging is, therefore, an agreement between competitors not to compete.

  - (b) geographical area where product or service will be rendered (market allocation)
  - (c) methods, factors or formulas used to calculate prices;
  - (d) the intention or decision to submit or not to submit, a bid;
  - (e) the submission of a bid which does not meet the specifications and conditions of the bid; or
  - (f) bidding with the intention not to win the bid.
- 8. In addition, there have been no consultations, communications, agreements or arrangements with any competitor regarding the quality, quantity, specifications and conditions or delivery particulars of the products or services to which this bid invitation relates.

#### 1. BACKGROUND

The Film and Publication Board requires the services of a Research specialist/organisation/company/Higher Education institution, to conduct six( 6 ) SADC country assessment reports to:

- Provide a detailed country report on Content regulation in respect of the seven
   (7) pillars identified;
- Comprise a holistic overview of the country Communication and digital technologies (or communications) regulator functions;
- Present the FPB with a detailed data-set including a ranking (using the FPB ranking system CCI Index) detailing the media content regulation frameworks in the below SADC countries.

The researched country reports and data produced, shall detail, using the CCI Index scale – seven (7) key pillars, place the data on the index namely:

- Transparency;
- Evidence-based classification ratings;
- Inclusivity in decision-making processes (including citizen recourse);
- Governance;
- Freedom of expression;
- Responsiveness to technology and innovation; and
- Accountability.

In addition to these pillars, the study will deep dive into the various classifiable elements, per country, looking holistically at classification decisions, that is: what informs the decision for any given rating and what classifiable elements are listed in each country.

Moreover, the service provider shall investigate measures that can be put in place to reassure the public that there is no significant divergence between societal norms and the regulator's decisions. In this phase of the project, the following countries shall be studied:

Botswana, Malawi, Seychelles, Tanzania, Zambia (SADC) and Kenya.

### 3. SCOPE OF WORK

- 3.1 Provide the FPB with six detailed country reports.
- 3.2 Detail using the FPB CCI matrix classifying these five SADC and 1 non SADC regulator (media content regulators in African countries), detailing the legislation (or pieces of legislation) in each respective jurisdiction that establishes the regulatory framework.
- 3.3 Present a defined ranking of these six countries using the current FPBs CCI ranking system. Compute these findings against the developed Content Classification Index (CCI), situating each according to its governance practices and structures along the identified seven pillars.
- 3.4 The service provider shall note adherence to principles enshrined in the Universal Declaration of Human Rights, other international and regional instruments with special focus on the rights of children, right to freedoms of association, speech, artistic expression, human dignity and other similar rights, in conducting this work and reference the six (6) countries' role and or position in relation to Human rights or regional instruments.
- 3.5 Develop an interactive dashboard (using drop downs as well as infographics) that virtually plots each media content regime according to set criteria as prescribed by the FPB. The dashboard should contain all the data per country that can easily be assessed (pivots).
- 3.6 Hand over the complete dashboard to the FPB Research Unit and train the team on the use of the dashboard front and back end additionally, how to add additional data as we grow the study.

- **4.5** Provide monthly comprehensive progress reports as well as quarterly cumulative reports on progress (dates to be provided by the FPB).
- **4.6** Final close out report as well as a PowerPoint presentation of the key findings of the project on completion to the FPB. Detailed empirically sound narrative reports must be produced
- **4.7** Submit a 250 word draft abstract and identify suitable international and local journals for potential publication.
- **4.6** Provide clear definitions for each pillar as well as an overall index ranking in order for the study to be repeated over time.
- **4.7** Provide a DASHBOARD system that allows for:
  - (i) As and when manual data entry for any additional country reports along the pillars specified in paragraph 1 above; and
  - (ii) Produce a dashboard that graphically (infographics and icons and or vectors) displaying a summary of the findings per country, time-period, pillar and allows comparison over time.
