A compulsory site inspection will be held at Friday, 26 September 2025 at 14:00. The Engineer will be present at the briefing, and all questions will then be answered. No further visits to the site will take place. Persons taking interest will gather at the Siyathemba Local Municipality, Van Wyk Street, MARYDALE 8910. Tenderers, who do not attend the compulsory site inspection, will expose their tenders to rejection.

Only Tenderers who satisfy the eligibility criteria stated in the Tender Data are eligible to submit tenders. Tenders will be evaluated and adjudicated in line with the Supply Chain Management policy of the municipality using an 80/20 preference points system, where the 20 points allocated for specific goals (locality) will be evaluated as follows:

Tenders must be registered with the CIDB in a CE Class of Construction Works, **Grade 6CE**, **(however, a 5CE PE grading will also be considered).** The grading designation must be equal to or higher than that determined in accordance with the sum tendered or a value determined in accordance with Regulation 25(1B) OR 25(7A) of the Construction Industry Development Regulation, 2004.

Except for the nominated sub-contractor, the contractor shall only appoint sub-contractors from the Northern Cape Province and ensure that the incorporation of these sub-contractors with the contract will run smoothly.

NB: Bids may only be submitted on the bid documentation provided by the municipality.

Their Tenders must bind Tenderers for a period of **90** (**Ninety**) days after Tender Closing Date.
