Only tenderers who meet the following requirements will be eligible for this bid;

- Proof of Central Supplier Database (CSD) registration
- Copy of Consolidated CSD and Tax Clearance Certificate for Joint Venture parties
- Proof of CIDB registration - Grade 9GB
- Valid COIDA certificate
- Copy of the certified valid tax clearance with Tax Compliance Pin certificate (TCC)
- Completion of SBD 1, 4, 6.2 and its Annexures C in full
- Completion of form of offer in the tender document in full
- Copy of the Joint venture agreement signed by both parties (where applicable Including apportionment of the JV)
- Proof of tender document purchase in the name of the bidding entity
- The bid shall be subject to 30% Sub-contracting in line with the PPPFA, PPR 2017 (Registered Companies with CIDB Grading)
- Public Liability Insurance Cover (R10 Million or above)

Note: (i) Failure to submit any of the above documents / requirements shall result in immediate disqualification of the bid.
(ii) Failure to complete and sign any designated spaces in the bid document shall result in immediate disqualification of the bid.

Only competent bidders who are competent in the advertised work and who have exceeded the minimum functionality threshold will be evaluated on a 100 (Price) points based on the Treasury Regulations of 2017, where functionality will be evaluated as follows:

Stage 1:

Qualified professional staff in the civil/building engineering field	20 points
Proof of plant ownership/ plant lease agreement/ hire arrangements	10 points

Financial viability (See page 12)	10 points
Total	100 points
NB: Minimum qualifying threshold 70% (70 points)	

Stage 2:

The Preferential Point System will be applied, where 100 points will be allocated for pricing only.

The IDT Quantity Surveyor (QS) will first conduct a risk assessment on all bidders who obtained a minimum threshold of 70% (i.e 70 points) in the functionality stage before the application of 100 pricing criteria. Bidders are requested to price each line item of the Bills of Materials (BOM). Should the bidder be deemed too risky to complete the project based on the QS's risk assessment report, they will be eliminated and not be considered for 100 pricing points evaluation criteria in line with the Preferential Procurement Policy Framework Act (PPPFA) of 2017.

Only bidders who obtain 70% (70 points) minimum functionality threshold will be evaluated further.
