1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

**1.2 To be completed by the organ of state**

The applicable preference point system for this tender is the 80/20 preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

**1.4 To be completed by the organ of state:**

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

**2. DEFINITIONS**

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

**4. POINTS AWARDED FOR SPECIFIC GOALS**

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—

## 1. BACKGROUND IZIKO

Iziko Museums of South Africa (Iziko) is a schedule 3A public entity and non-profit organisation, partly subsidised by the National Department of Sport, Arts & Culture (DSAC), bringing together 11 national museums and a Social History Centre situated in the Western Cape under a single governance and leadership structure. Iziko was established in terms of the Cultural Institutions Act, 1998 (Act No. 119 of 1998) and is required to comply with the Public Finance Management Act (PFMA), 1999 (Act No. 1 of 1999, as amended) and its concomitant Regulations.

## 2. SCOPE OF WORK

We require a service provider to facilitate and coordinate a community consultation event in Upington from 5-7 August 2025. The service will include event conferencing and accommodation for multiple participants from various locations. Some travel, event coordination, and associated logistics planning is required. This includes:

1. Accommodation for 30 people (include breakfast and dinner), single rooms. Please note that this amount may be reduced depending on final RSVPs. We would like everyone to stay at the conference venue but the 5 Iziko staff members can stay elsewhere, if required. Springbok Inn (just outside Springbok) or Okiep Country Inn (or similar) to be considered as we don't want the conference to be held too close to town.

Check in - 4 August 2025

Check out – 8 August 2025

2. Conference facility from 5 – 7 August 2025 from 9am to 6pm. The conference venue must include chairs, tables, pens and notepads.
  - Venue must cater for 10am tea, 1pm lunch, and 3pm tea. Biscuits, sweets, and Coca-Cola to be provided for all participants.
  - Venue must have a smoking section.
3. Payment of participant travel stipends of R600 each for 24 people for the event in Springbok.
4. Flights for eight (8) people to Glasgow, Scotland end-August 2025 and accommodation (bed and breakfast) for each person for 5 nights. Accommodation to be near The Hunterian Museum (University Ave, Glasgow G12 8QQ, United Kingdom).
5. Contingency of 15% to cover any unforeseen requirements for the event or travel arrangements.

### 4. EVALUATION PROCESS

#### 4.1 Evaluation of Quotation

The contract shall be awarded at the sole and absolute discretion of Iziko. Iziko hereby represents that it is not obliged to award this quotation to any bidder. Iziko is entitled to **retract** this quotation at any time as from the date of issue or reduce deliverables.

All quotations will be evaluated according to the criteria, weightings and threshold scores as Indicated in 5.2 below:

#### 4.2 Evaluation Criteria

The selected service provider shall be required to indicate their capacity to deliver the services required by Iziko as per the requirements below. Bidders are required to achieve a score of 80 points to be considered for the SPECIFIC GOALS and Price evaluations.
