1. PURPOSE

The purpose of this request is to appoint a service provider for the construction of 5 zone toilets in the Tsitsikamma Section of Garden Route National Park.

2. BACKGROUND

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs. This places SANParks in an ideal position to not only meaningfully contribute to the protection and sustainable use of the megadiverse biodiversity of South Africa, but also to be a key player in building climate resilience through ecosystem-based mitigation and adaptation.

3. SCOPE OF WORK

Supply and Installation of Five (5) Standalone Toilet Container Units

1. General Description

The contractor shall supply, deliver, install, test and commission five (5) complete standalone toilet container units at designated locations within Tsitsikamma National Park.

The works shall include all labour, materials, plant, transport, excavation, plumbing, drainage, septic systems, water storage systems, solar lighting systems, testing and commissioning necessary to provide fully operational toilet facilities.

The contractor shall undertake a site inspection prior to commencement and verify all site conditions.

2. Container Structure

Each toilet unit shall comprise:

- Converted steel container or prefabricated modular structure
- Minimum dimensions: 2.4m x 2.4m x 2.6m
- Welded structural steel frame
- Anti-corrosion treatment and external weatherproof paint finish
- 50mm insulated chromadek sandwich panels or equivalent
- Waterproof and non-slip floor finish
- Insulated roof structure with weatherproof sealing
- Internal ceiling lining
- Stainless steel ventilation grilles
- Complete fixing and anchoring system

3. Civil Works and Foundations

The contractor shall:

- Set out all toilet positions
- Clear and prepare installation areas
- Excavate for foundations
- Construct reinforced concrete foundation slabs
- Construct concrete plinths where required
- Backfill and compact excavated areas
- Remove surplus excavated material from site

4. Plumbing and Sanitary Installations

Each toilet unit shall be fitted with:

Toilet

- 1 x Floor-mounted ceramic toilet pan
- Dual-flush cistern
- Toilet seat and lid
- Associated water supply pipework
- Isolation valves
- Waste connections

Wash Hand Basin

- 1 x Wall-mounted ceramic basin
- Chrome plated mixer or pillar tap
- Bottle trap
- Waste pipework
- Isolation valves

Accessories

- Mirror
- Toilet roll holder
- Soap dispenser
- Coat hook
- Towel hook
- Signage

5. Water Supply System

Each toilet unit shall include:

JoJo Water Storage System – To be supplied by Contractor

- 1 x 1000 Litre JoJo Tank
- Pressure-treated timber stand
- Minimum five 200mm diameter support posts
- Elevated rigid platform
- Inlet and outlet pipework
- Isolation valves
- Overflow pipe
- Tank securing straps
- Complete connection to basin and toilet

6. Septic Tank and Drainage System

For each toilet facility, the contractor shall:

Excavation

- Excavate for septic tank installation
- Excavate trenches for pipework and soakaways
- Dispose of surplus spoil

Septic Tank

- Install 1 x 1 200 Litre septic tank **per** toilet facility
- Septic tanks will be supplied by SANParks
- Concrete bedding where necessary
- Complete inlet and outlet connections

Soakaway System

- Construct soakaway system
- Minimum 20 metre perforated drainage line
- Wrapped with geotextile membrane
- Filled with approved soft rock drainage media
- Inspection points
- Rodding eyes
- Ventilation system

Drainage

- 110mm UPVC sewer pipe
- 40mm PVC basin waste pipe
- Inspection chambers
- Testing of all drainage systems

7. Electrical and Solar Installation

Each toilet unit shall be provided with:

- Solar panel system
- Solar charge controller
- Battery system
- LED bulkhead light
- Weatherproof light switch
- Surface mounted conduit
- **Anti-theft galvanized steel cage protecting solar panel**
- Complete wiring and testing

8. Ventilation

Each unit shall include:

- Louvred vents
- Vent stack minimum 1.5m above roof level
- Insect screens
- Mechanical extractor fan

9. Testing and Commissioning

The contractor shall:

- Pressure test all water pipework
- Test drainage systems
- Test solar lighting systems
- Demonstrate operation of all installations

- Rectify defects
- Clean site and facilities
- Provide handover documentation

4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents) - RETURNABLES

SANParks has set out the minimum administrative criteria that must be met by a bidder. The below administrative documents must be completed and signed by the authorized representative of a bidder. - (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).
