This is a request to lease out the tuckshop based at Tutuka Power Station premises measuring to 294m² (consisting of a tuckshop and dining area 236m²; storage 58m²). The building is adjacent to the Main Administration Building and within Lekwa Local Municipality in Mpumalanga Province. The lease will probably commence on the 1 January 2024 for a period of three years from date of signature.

1. BUILDING DISCRIPTION

The property consists of a Kitchen, Dining and Storeroom, is constructed of brick and mortar of bag wash to exterior plastered and painted internally under flat bituminous roofing underlined by rhino board ceilings. Solid concrete floors fitted with ceramic tiling. Windows are glazed on steel framing secured by burglar proofing. The retail area is fitted with ceramic tiling and wooden doors that open to an open kitchen and dining area. The kitchen is fitted with steel cabinets, a gas stove, and smoke extraction furnaces directly above the stove. 
