### **1. INTRODUCTION AND PURPOSE**

**Quotation for the supply, delivery and offloading of glyphosate herbicides to the poison store (Store S010).**

### **2. BACKGROUND**

This quote is only for glyphosate herbicides. These herbicides are used mainly by the following Departments/Divisions/ sections for the following reasons and from these reasons the impact on service delivery can be assessed:

- € Roads and Storm Water – spraying of weeds in the pavement and road verges and in front of traffic signs and robots.
- € Nature Conservation- treatment of invaders
- € Resorts – spraying of weeds and long grass in and around the picnic areas.
- € Urban Management – Spraying weeds in paving
- € Electricity- Spraying weeds around power substations in the residential areas.

The store issues the poisons via reservations on SAP under store S010.

### **3. PROJECT SCOPE**

#### **3.1 SUPPLY AND DELIVERY OF THE PRODUCTS**

All products must be delivered to Poison Store- Store S010 situated at the Centurion Mega Store (252 Basden Avenue, Die Hoewes, Centurion). Delivery

will only be allowed deliveries can only be made by appointment with the Storekeeper.

- Delivery must take place within 10 working days after the vendor has received the official purchase order form from the City of Tshwane.
- Labour for off-loading must be carried by the vendor and containers are to be off loaded inside the store.
- All containers must be intact as no damaged containers will be accepted.
- The weight or volume must be exact as to what is stated on the labels.
- Containers must be sealed as prescribed in Section 9(1) of the Law on Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act 1947 (Act 36 of 1947) - Regulations regarding fertilizers.
- All Labels must comply with the following specifications. No product will be accepted if it does not comply with these specifications. The manufacturers label must remain on the container. No poison may be decanted into smaller containers. Vendor must supply the trade name of the product to be offered.
- The vehicle delivering the herbicide must have the necessary warning labels on the vehicle during transport as well as process and packaging during transportation of poisons must be in accordance with:
  - ☐ SANS 10228: 2003: The identification and classification of dangerous goods for transport.
  - ☐ SANS 10229: 1996 Packaging of dangerous goods for road and rail transportation in South Africa.

### 6.3 Preferential Scoring Points

The preferential points to be used will be the 80/20 points system in terms of the Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000) Regulations 2022.

- € 80 points for price
- € 20 points for specific goals
  - € Bidders are required to submit supporting documents for their bids to claim the specific goal points.
  - € Non-compliance with specific goals will not lead to disqualification but bidders will not be allocated specific goal points. Bidders will score points out of 80 for price only and zero (0) points out of 20 for specific goals.
  - € Cot shall act against any bidder or person when it detects that the specific goals were claimed or obtained on a fraudulent basis.

Further action on failures by the supplier to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The city further reserves the right to negotiate a market related price with a tenderer scoring the highest points. If the tenderer does not agree to a market-related price, the city reserves the right to negotiate a market-related price with the tenderer scoring the second highest points, if the tenderer scoring the second highest points does not agree to a market-related price, negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the city reserves the right to cancel the quotation.
