1.1 DESCRIPTION OF SERVICE: CROSS-RIPPING OF 0.74HA OF SOIL TO 1M DEPTH AT BIEN DONNE RESEARCH FARM.

BACKGROUND:

The stone fruit reference collection block at Bien Donne Research Farm is being updated on a yearly basis with new varieties to use it as a comparative block for granting Plant Breeder's Rights and Variety listing to new variety applications. A new block, namely BD7B will have to be prepared for planting purposes, as the current block has reached its maximum planting capacity. Soil type of block BD7B is clay-loam.

PURPOSE

Cross ripping of 0.74ha (7400m²) soil to 1 m depth at Bien Donne Research Farm.

SCOPE OF WORK

Service Provider to cross rip Block BD7B to 1 m depth at Bien Donne Research Farm. Size of Block BD7B: 0.74ha (7400m²). Soil type: Clay-loam. The quote must include wet rate, i.e. diesel and operator included, and transport costs of machine to and from work site at Bien Donne Research Farm. Hours needed for machine/ripper: 8 hours.
