### 3. BACKGROUND

The South African Broadcasting Corporation Limited (SABC)NW situated in Mafikeng Cnr Dr Albert Luthuli Drive and James Moroka seeks to appoint a service provider for upgrade of **Motsweding FM Studios**.

The South African Broadcasting Corporation (SABC) previously initiated a project for the full interior refurbishment and acoustic upgrade of the SABC Mahikeng Broadcasting Studios (North-West). A primary contractor was appointed and successfully completed approximately 90% of the planned refurbishment works.

However, due to unforeseen circumstances, the initial contractor was unable to finalize the remaining scope. Consequently, this Request for Quotation (RFQ) is issued to appoint a capable and suitably qualified contractor to execute the "Phase 2 Refurbishment" / Completion Works. The appointed contractor will be responsible for completing the final 10% of the project, ensuring the studios are brought to full operational readiness and meet the required broadcasting and acoustic standards.

The current project entails the final fit-out, acoustic detailing, and aesthetic completion of various broadcasting spaces, including the Main Studios , News Studios, Control Rooms.

Because the project is already 90% complete, the incoming contractor will be required to seamlessly interface with the existing finished elements. **Please note:** Certain materials required for the completion of the works are already stored on-site (as indicated in the attached BOQ). The contractor will need to take custody of these materials, supply any outstanding materials listed in the BOQ, and provide the specialized labor and management required to finalize the installation.

### 4. REQUIREMENTS AND SCOPE OF SERVICES

The Scope of Works covers the final finishing trades, acoustic sealing, minor services, and general making-good of the studio environments. The specific tasks include, but are not limited to:

#### 4.1 Preliminaries & Site Management

- Full-time site supervision, project administration, and Health & Safety compliance (Act No. 85 of 1993).
- Coordination with and assistance to specialized SABC equipment and furniture installers as required.
- Protection of the existing 90% completed works during the execution of the final tasks.
- Final rubble removal, cleaning, and making the site good prior to occupation.

#### 4.2 Acoustic Treatments & Paneling

- Installation and assembly of final acoustic wall panels.
- Supply and installation of acoustic base traps (24 x 400mm x 400mm x 1800mm).
- Application of specialized sound seals between acoustic boxes/partitions to maintain acoustic integrity.

#### 4.3 Ceilings & HVAC Finishes

- Completion of Class A absorption suspended ceilings.
- Minor demolition/adjustments within the ceiling voids where necessary.
- Supply and installation of new flush-mounted HVAC inlets, return air grilles (white powder-coated, 600x600mm), and duct extensions.

#### 4.4 Floor Finishes

- Installation of carpeting (client-supplied carpets to be installed on 3mm rubber underlay as per the room schedules).
- Supply and installation of associated floor skirtings.

#### 4.5 Doors, Windows, and Carpentry

- Full servicing, alignment, and refurbishment of existing acoustic doors to ensure a perfect sound seal.
- Carpentry works and finishing adjustments to existing window frames and acoustic windows.
- Supply and installation of dado rails and top holding cornices.

#### 4.6 Minor Electrical & Lighting

- Removal, cleaning, safe storage, and refitting of existing passage lights onto the new passage ceilings.
- Supply and installation of new studio lighting, including downlights (e.g., 5W 240V GU10 LED bulbs) as per the lighting layouts.
- Assisting the broadcast equipment installer with final electrical point positioning and connections.

#### 4.7 Signage

- Supply and installation of standard studio signage as specified in the BOQ.

### 5. **RFQ Validity period**

This bid will remain valid **90 (ninety) days** from the date of closing.

### 6. **Costing**

The quotation must reflect a detailed cost breakdown, and any indirect costs associated with the rendering of required service as per the schedule in the Scope of Service

### 7. **Duration of the Contract**

2 months for completion of the project

**c. ADJUDICATION USING A POINT SYSTEM**

- The bidder obtaining the highest number of total points will be awarded the contract.
- Preference points shall be calculated after process has been brought to a comparative basis taking into account all factors of non-firm prices.
- Should two or more bids be equal in all respects, the award shall be decided by the drawing of lots.

d. **Objective Criteria**

- The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay The SABC reserves the right not to award this tender to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- The SABC will not award contract/s to the bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance, company financials, etc. will be eliminated from the bid process.
- The SABC reserve the right not to award this tender to any bidder who fails the financial stability assessment.
- No SABC former employees shall be awarded contracts with the SABC within **12 months** after termination of employment with the SABC.
- Should employees resign or retire from the employment of the SABC and become directors of other businesses tendering with the SABC, such tender shall not be considered until the cooling off period of 12 (**Twelve**) months has expired.
- Should the employee be dismissed from the SABC employment, such employee shall be prohibited from conducting business with SABC for a period of **5 (Five)** years from the date of dismissal.
- Should the employee be found guilty in a court of law due to criminal conduct/act, such employee will not be considered to do/conduct business with SABC, until the criminal record has been legally expunged.
- The SABC shall not procure any goods, services, works or Content from any Board member or Board member owned business, to ensure that suppliers competing for the SABC's business have confidence in the integrity of SABC's selection process.
- Should the SABC's Board members no longer serve on the SABC Board but become directors of other companies, the SABC shall not conduct business with those companies until the cooling off period of **12 (Twelve)** months has expired.

## 11. **COMMUNICATION**

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

## 12. **CONDITIONS TO BE OBSERVED WHEN TENDERING**

- The corporation does not bid itself to accepts the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.
- No tender shall be deemed to have been accepted unless or until a formal contract / letter of award is signed by both parties.

- **The Corporation reserves the right to:**
  - Make a selection solely on the information received in the submissions
  - Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.
  - Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.
  - Cancel this RFQ or any part thereof at any time.
  
- Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs, aligned to the BEE & Price.

### 13. **Cost of Bidding**

The Tenderer shall bear all costs and expenses associated with preparation and submission of its tender or RFQ, and the Corporation shall under any circumstances be responsible or liable for any such costs, regardless of, without limitation, the outcome of the bidding, evaluation, and selection process.

### 14. **PAYMENT TERMS**

SABC will effect payment sixty (60) days after the service provider has rendered the service and submitted an invoice / statement.

**1. GENERAL CONDITIONS**

1.1 The following preference point systems are applicable to invitations to tender:

- the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
- the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 **To be completed by the organ of state**

a) The applicable preference point system for this tender is the **80/20** preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- (a) Price; and
- (b) Specific Goals.

1.4 **To be completed by the organ of state:**

- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

## 2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation.

**4. POINTS AWARDED FOR SPECIFIC GOALS**

4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
