1.1 DESCRIPTION OF SERVICE: CONTINUOUS SOIL MOISTURE LOGGING PROBES WITH SOFTWARE

BACKGROUND:

The continuous soil moisture logging probe should be able to take readings on 6 depths at hour intervals and store the information locally for up to 60 days. The outer shell of the probe should be made of UV Stabilized PVC, and the inner shell should be made of a solid resin cast. The probe data software should be able to interpret the soil water content and temperature readings.

The capacity of the probe should be able to store up to 4000 readings.			
The data should be able to be downloaded to a mobile logger or to a central computer with the use of a 1.0-1.3 km long-distance radio model.			
The life expectancy of the battery should last for at least 12 months			
The researcher must be able to use download the information without physical visit each probe.

1.6 The purchaser reserves the right to require of a bidder, either before a bid is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the purchaser.
