Our **mandate** is the delivery of Conservation Mandate by Excelling in the Management of a National Park System

Our **mission** is to develop, protect, expand, manage, and promote a system of sustainable national parks that represents natural and cultural heritage assets, through innovation, excellence, responsible tourism and just socio-economic benefit for current and future generations.

## **BUSINESS UNIT RESPONSIBLE FOR THE BID**

SANParks is inviting interested Service Providers to design, develop and facilitate a customised comprehensive Customer Service Training Program aimed at enhancing service delivery across SANParks integrated tourism and hospitality operations.

The selected service provider will be responsible for:

- Conduct Pre learning needs assessment
- Design and deliver training content that addresses customer service, environmental interpretational and professionalism.
- Align training with the organization's values, hospitality, tourism and visitor experience standards.
- Promote service excellence across all touchpoints—from arrival at gates to accommodation, guides, and departure.
- Training Delivery (face to face / blended)
- Between strong and weak customer care, within the hospitality industry, particularly relating to a professional image, communication skills and complaint handling as well as recognising how to present a professional image and techniques for communicating positively and effectively with customers, including verbal and non-verbal communications.
- Service Culture Handbook with SOPs and guest interaction guidelines.
- The service provider assesses the impact and effectiveness of the training program (individual, organisational, customer).

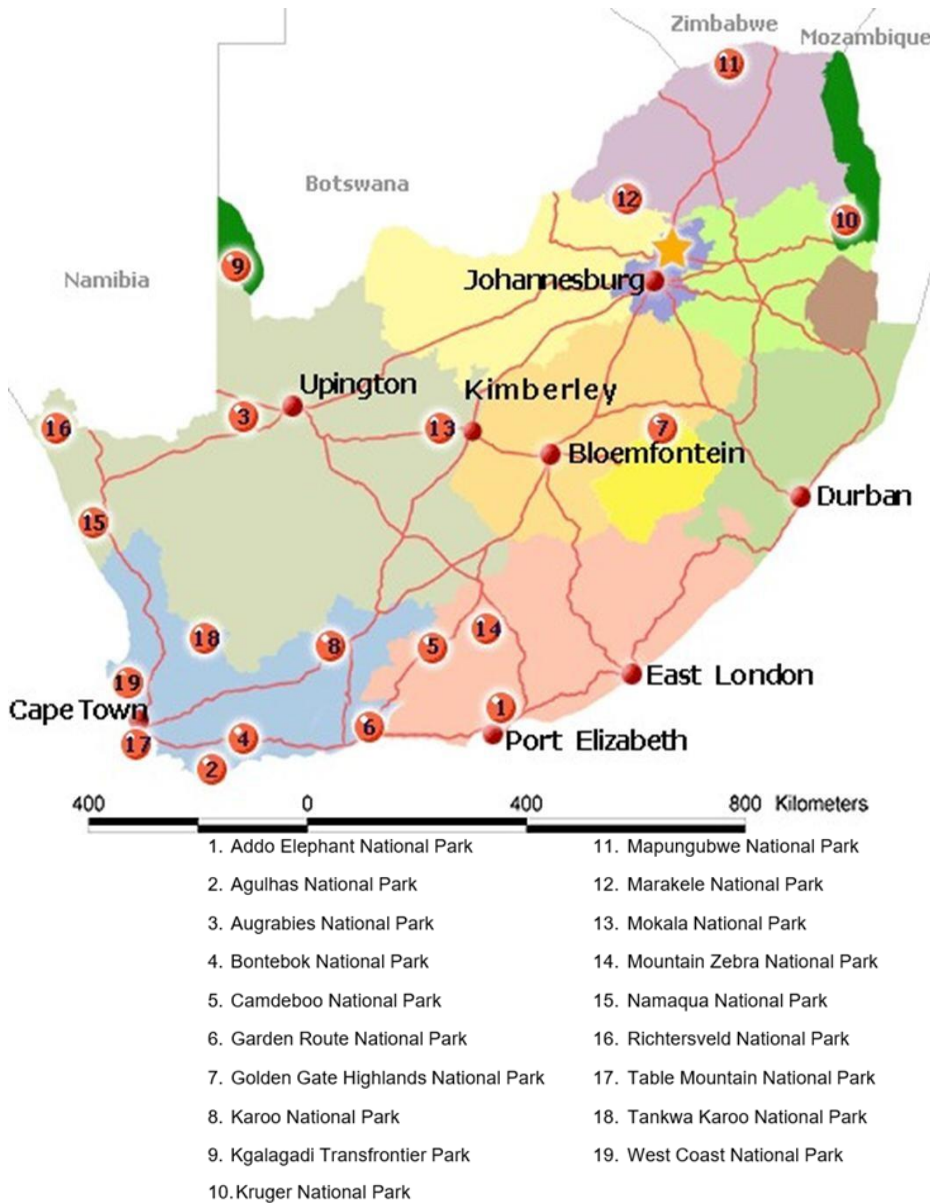

## PARTICIPANTS

The total number of participants for the programme is 1500 across all parks and targeted participants will be call center agents, gate officials and guides to housekeeping and hospitality services.

## GEOGRAPHICAL SCOPE

SANParks operations and users are distributed across South Africa where it operates parks. Below is a map showing all currently functional parks managed by SANParks.



The organisation also has management and operations facilities outside of its own parks, such as the Groenkloof head office in Pretoria, satellite offices, sales offices and partner parks.

The customer service training will be implemented in all national parks as outlined on the map.
