Nkomazi Local Municipality cordially invites interested parties which are registered **as CIDB Grading 6CE or higher on the CIDB register** of contractors to tender/bid for the Rehabilitation of Block B Ring Road for Nkomazi Local Municipality. Tender documents with complete details are available upon payment of a non-refundable amount of R1 740.02 on each tender document or can be downloaded for free on the E-tender portal. Tender document(s) will be available as from **28/10/2025** and are obtainable at Nkomazi local Municipality's Budget and Treasury Office (Old Malelane Taxi rank) 22 Impala Street Malelane 1320 from the cashier's desk at 07H30 till 15H30 (Monday to Friday)

A non-compulsory briefing session will be held at **10H00 on 30/10/2025** at the Municipal town hall (Kobwa hall) at Fish Eagle. Bidders are advised not to commit fraudulent activities or forged documents. All abusers of the SCM system, including or faking of returnable documents may be reported to the SAPS and may be restricted from doing business with any public institution for a period not exceeding 10 years in line with sections 28 and 29 of the prevention and combating of corrupt activities Act 12 of 2004.

A preferential system shall apply whereby this contract will be allocated to bidder in accordance with the preferential procurement policy framework Act no. 5 of 2000 and as defined in the bid document, read in conjunction with the preferential procurement regulation 2022 where 80 points will be allocated in respect of price and 20 points in respect of targeted goals. Completed Bid documents must be deposited on/before **12H00 on 14/11/2025** on the tender box located at the main entrance of the municipality (Civic Centre), 9 Park Street Malelane 1320

Tender/bid documentation must be submitted in a sealed envelope or container on which the tender/bid number and addresses are clearly marked. No tenders /bids transmitted by fax or E-mail will be accepted. It must be noted that the municipality is not bound to accept the lowest bidder on any tender. Tenders/Bids documents received after the bid had been closed will be ignored. It must also be noted that a tender submitted in the wrong tender box will not be considered. Nkomazi Local Municipality supports the empowerment of the previously disadvantaged and SMMEs.
