REQUEST FOR QUOTATION 2-IN-1 NOTEBOOK COMPUTERS

1 INTRODUCTION

The purpose of the RFQ is to solicit quotations for the procurement of 100 Two-in-One Notebook Computers. A 2-in-1 defined as a Personal Computer that has the features of both a notebook and a tablet.

2 BACKGROUND

PRASA has an urgent requirement to procure 2-in-1 Notebook Computers. The 2-in-1 Notebook Computers were not awarded in the desktops/notebooks tender that was finalized in February 2022. As such, a separate procurement process is being followed for the procurement of the devices.

3 SCOPE OF WORK

PRASA has a requirement of 100 "2-in-1" Notebook Computers.

4 SPECIFICATION OF THE WORK OR PRODUCTS OR SERVICES REQUIRED

In the table below, it is the minimum specification for the required 2-in-1 Notebook Devices. Bidders are required to proposed notebook computers that meet the device specification below. **All specification required must be met.** Failure to meet all requirement will lead to the disqualification of the bid.

Stage 1A - Mandatory Compliance Requirements (Substantive Responsiveness)

If a supplier / bidder does not submit the following documents the Proposal will be disqualified automatically:

9.2.2 STAGE 3 - Pricing and BBEE

Pricing Evaluation: Only Bidders who have proposed computer devices that meet all specification requirement under Stage 2 will be evaluated for BBEE and Price. The submitted price MUST include all items in the device specification requirement. For example, tracking software, bags, cable locks, etc.

BEE Evaluation: The B-BBEE component of evaluation is weighted at 20% of the evaluation criteria. Determination of points of B-BBEE is based on the B-BBEE Recognition Level as per table below:




