1. PURPOSE

The purpose of these terms of reference (ToR) is to invite or request bidders to submit quotations for appointment of a Service provider for the Services of rendering electrical works of staff accommodation [two room apartments including solar in Agulhas National Park.

2. LOCALITY

Agulhas National Park is situated 220km from Cape Town.

3. INTRODUCTION

South African National Parks (SANParks) is a public entity functioning under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003); with the mandate to conserve; protect; control; and manage national parks and other defined protected areas and their biological diversity (Biodiversity). As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entities.

SANParks' operations are totally guided by its vision statement and mission statement. As a public entity, the organisation is committed to act in pursuance of transformation of South Africa's society in support of entrenching South Africa's democracy. In this regard, the organisation has adopted a transformation mission to guide its efforts accordingly.

4. BACKGROUND

This small camp/ two bedroom house is located +/-12km from the Cape Agulhas Lighthouse. The camp was placed and designed to meet high environmental standards and according to the 'touch-the-earth-lightly' principles by which, inter alia, development was limited to disturbed sites.

The site is very popular and offers the following:

- Two Room units, each with, en-suite bathrooms (toilet/ shower),
- The House is not supplied with electricity but require solar to be incorporated as most items are procured to date .

5. **SCOPE OF WORK**

The appointment of an accredited service provider for the remedial electrical reticulation inside the two-bedroom house and installation of a 6KW solar off grid installation and standby power that will integrate with the current electrical

The following detail on the proposed projects will clarify the Scope of Works.

- All works to comply with the proposed estimated [to be use as guideline] specification as per **BoM** .
- All work to conform to OHS act 85 of 1993 regulations standards and risk profiles. The contractor is responsible to maintain the relevant documentation on health and safety and should be able to provide the information to the Park on request
- Material risks to be mitigated by the contractor and will be his responsibility till after commissioning, and the remaining warranty period
- All defective equipment / faulty parts to be communicated for remedial action
- The installation warranty effective date commences on the day of commission and handover where all parties signed off the documents received as below;
 - a) COC
 - b) As build drawings and wiring diagrams
- The commissioning will be authorised by an official from the SANParks Technical office. This will also require a Service Level Agreement to ensure a warranty for 12 months which includes;
 - Technical Support
 - Performance Analysis
 - Ensuring optimal functioning of equipment installed

6. **ELIGIBILITY CRITERIA**

Only those service providers who satisfy the following eligibility criteria and who provide the required evidence in their submissions are eligible to submit bids and have their bids evaluated:

Mandatory Requirement

The Service Provider -

- (i) Is not an unincorporated joint venture.
- (ii) Is registered in terms of the Companies Act, 2008 (Act 71 of 2008) or Close Corporation Act, 1984, (Act No. 69 of 1984) or, if a partnership, has in place a partnership agreement that enables the partnership to continue to function in the event of a death or withdrawal of one of the partners.
- (iii) The bidder or any of its directors is not listed on the Register of Tender Defaulters in terms of the Prevention and Combating of Corrupt Activities Act of 2004 as a person prohibited from doing business with the public sector.
- (iv) The bidder has not:
 - Abused the employer's supply chain management system;
 - or
 - Failed to perform on any previous contract and has been given a written notice to this effect.
- (v) The bidder must provide:
 - Proof and copy of valid Department of Labour registration
 - Copy of ID for registration as an IE or ME (both sides)
 - mandatory site visit is required to ensure the work and scope in clarified for this RFQ

7. **CIDB GRADING**

Contractors registered by the Construction Industry Development Board with a grading of **1 EP** or higher will qualify for this contract.

13. EVALUATION FORMULA FOR PRICE

The following formula will be applied to calculate the scores:

Price Formula

The following PPPFA formula was used to evaluate the price proposals submitted by bidders, this formula was used because price was the only criterion that was scored i.e. the whole 80 points were allocated to price.

$$P_s = 80 \left(1 - \frac{P_t - P_{\min}}{P_{\min}} \right)$$

P_s = Points scored for price of the bid under consideration.

P_t = Rand value of bid under consideration.

P_{\min} = Rand value of lowest acceptable bid

14. PROTECTION OF PERSONAL INFORMATION ACT, 4 OF 2013 (POPIA)

16. FINANCIAL PAYMENT

Payment will be made in accordance to the PFMA (within 30 days of receipt of invoice) after delivery of service rendered or goods delivered.

17. FINAL AWARD

SANParks nominates the bidder with the highest combined score for the contract award subject to the bidder having supplied the relevant administrative documentation.

SANParks reserves the right not to award to the highest points scorer in accordance with S 2(1) (f) of the Act (PPPFA).

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

80/20

$$Ps = 80 \left(1 - \frac{Pt - P_{min}}{P_{min}} \right)$$

Where

Ps = Points scored for price of tender under consideration

Pt = Price of tender under consideration

Pmin = Price of lowest acceptable tender

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender.
