1. INTRODUCTION AND PURPOSE

This quotation is for the once off purchase and delivery of a Class 1 Impulse Integrated Sound Level Meter for the Municipal Services Section.

2. PROJECT SCOPE

Noise control is one of the main key performance areas rendered by Municipal Health Services (MHS) in the City of Tshwane. The Gauteng Noise Control Regulation, 1999 is the legal platform, used by MHS to enforce noise control in the City of Tshwane. A Class 1 Impulse Integrated Sound Level Meter is a legal requirement for law enforcement purposes and court cases, according to the Gauteng Noise Control Regulation.

3. SPECIFICATIONS

Important Requirements & features of Sound Level Meter (SLM):



NB: PICTURES ARE FOR VISUAL PURPOSES ONLY

- 3.1. The Sound Level Meter, hereafter referred to as a SLM, must be of the digital processing type for both the display and the signal processing. (Analog type instruments will not be considered).
- 3.2. The SLM must perform Real Time Analysis with 1/3 octave band resolution and

- must have a Live display of sound spectra of these bands on the instruments display. (NB! Serial or sequential band filters will not be acceptable)
- 3.3. The SLM must also be capable of storing the 1/3 octave spectra for later analysis. Also, the 1/3 octave spectra must be able to store and display the Leq or LAeq or LA max values.
 - 3.4. The SLM must perform Time History over programmable preset measuring intervals. It must be Auto Data-logging type.
 - 3.5. The Frequency weightings of the SLM must be selectable for A, C and Flat weightings and time weighting Fast, Slow and Impulse.
 - 3.6. Simultaneous Processing of Measurement Functions: The SLM must be capable of measuring and capturing at least the following parameters simultaneously. (While viewing one measurement it should capture all the others)
 - LAp. – A weighted Sound level*
 - LAeq- A weighted Averaging sound level*
 - LAI.eq- Impulse A weighted Averaging sound level*
 - Lmin & Lmax*
 - Ln- Percentile sound level*

*All the above must be selectable to be measured in A, C & Flat weightings and in various time weightings of Slow, Fast or Impulse.
 - 3.7. The Measuring range shall be 30 to 135 dB (A) RMS or greater.
 - 3.8. The dynamic range of the SLM on a single range setting shall be greater or equal to 80 dB.
 - 3.9. Other Important requirements:
 - 3.9.1 Must have Back Erase function to erase unwanted noise events/occurrences from a long-term reading.
 - 3.9.2 User Selectable measuring times from 10 seconds to 24 hours on all functions.
 - 3.9.3 Instrument must have a real time clock: Year, month, date and time in Hours, Minutes and Seconds.
 - 3.9.4 Frequency response range shall be 20Hz to 20kHz. (Including the microphone)
 - 3.9.5 Battery type: SLM operating on Standard AA penlight batteries or Nickel metal hydride rechargeable will receive preference. Instruments operating on the expensive NEDA 9-volt battery will only be considered if it offers exceptional long operating battery life.
 - 3.9.6 Battery Life should be greater than 20 Hours on a fresh set of alkaline batteries.
 - 3.9.7 The preamplifier and microphone must be detachable from the SLM main unit such that an extension cable of at least 10 meters can be fitted.
 - 3.9.8 Instrument must have backlighting on the display for use in poor lighting or nighttime readings.
 4. SLM must be supplied with the following:
 - 4.1.1 Real Time Analyzer option installed.
 - 4.1.2 Carry case.
 - 4.1.3 Collapsible Tripod.
 - 4.1.4 Microphone windscreen.
 - 4.1.5 Flash memory card or onboard memory for data-logging and downloading to a PC.
 - 4.1.6 SLM to be supplied with card reader and/or data download cable for PC interface.
 - 4.2 Set of Ni MH rechargeable cells and one charger per SLM

4.3 Operating Manuals and interface manual.

4. CONDITION

The service provider must provide a minimum warranty period of one (1) year or more on all items, effective from the date of delivery.

Further action on failures by the service provider to deliver will be handled in terms of the contract including performance warnings and listing on the database of restricted suppliers.

The City further reserves the right to negotiate a market related price with a bidder scoring the highest points. If the bidder does not agree to a market-related price, the City reserves the right to negotiate a market-related price with the bidder scoring the second highest points, if the bidder the second highest points does not agree to a market-related price, the City will negotiate a market-related price with the tenderer scoring the third highest points. If a market-related price is not agreed, the City reserves the right to cancel the quotation.
