1. INTRODUCTION AND BACKGROUND

- 1.1. The Office of the Chief Procurement Officer (OCPO) within National Treasury (NT) was established for among others to modernise and automate Supply Chain Management (SCM) processes with a view of improving public sector procurement performance.
- 1.2. A need to review the manner of procuring certain strategic commodities for the State has been identified. Security Services is one of the commodities that requires the differentiated approach of procurement. Therefore, the Chief Directorate: Strategic Procurement is in the process of developing minimum bid specifications and documents to be loaded in specification library on the e-Tenders portal to be accessed by all spheres of government when procuring security services.
- 1.3. To advance this process further, the industry / service providers are consulted as one of the key procurement stakeholders identified to play a critical role of providing technical information on the services mentioned.
- 1.4. The National Treasury (OCPO) invites interested and qualified service providers to participate in a virtual Request for Information (RFI) session regarding the specification for provision of Government Buildings Security Services across the National, Provincial and Public Entities.
- 1.5. It is on this basis that this Request for Information (RFI) is advertised on the National Treasury website (www.treasury.gov.za) and on the government eTenders portal (www.etenders.gov.za) which will be available from the 7th to 27th October 2025.

2. THE PURPOSE OF THE REQUEST FOR INFORMATION

- 2.1. The purpose is to invite Security Service Providers and the industry to share their insights and feedback on the draft specification.
- 2.2. Ensure the specification is, comprehensive, generic and aligned with the market.

- 3.1. To familiarise themselves to the attached draft specification (**Annexure A**) and bring their input to the meeting for discussions.
