# **DETAILED TECHNICAL SPECIFICATION**

# 1. Background

The SABC Western Cape office requires the services of a suitably qualified service provider to provide maintenance, service, repair or replacement work to various **Security and Access Control** equipment such as full HD IP Hikvision cameras and CCTV system, Access Control equipment (card readers, maglocks, turnstiles etc.), roller doors, motorized doors and sliding gates.

## 2. Requirements / Items in Scope

#### **Access Control and Turnstiles:**

- Adhoc servicing and repairs of the security equipment (turnstiles, CCTV cameras, metal detectors, X-ray machines, electric fencing, motorised gates and associated equipment; as well as problem solving on the SoftCon Access Control Software to ensure optimal operation of all equipment and software.
- · Respond to callouts to do fault finding and quote on repairs/replacement when required
- Check motors and all moving parts of the turnstiles
- Check all electrical parts and operation of the turnstiles
- Lubricate parts where required
- The service provider will be expected to replace all the parts and components as necessary (Quoted separately)
- Service providers must have specialised knowledge of SoftCon access control software
- Installation/Repair of access control equipment e.g. maglocks, readers, controllers etc.

#### **CCTV Cameras:**

- Respond to callouts to do fault finding and quote on repairs/replacement when required.
- Checking cameras and CCTV (DVR/NVR) systems
- Cleaning camera glass and lenses
- This contract will <u>not</u> include new installations. New supply & fit installations will go out to market.

#### Gates:

- Quarterly service of the gate motors and moving parts.
- Respond to callouts to do fault finding and quote on repairs when required
- Check the sensors to ensure they are working properly
- Check the gate wheels, bearings and replace if worn out
- Lubricate parts and add oil where required
- Check the batteries and charger if they are fully functional, repair or replace if required

- The service provider will be expected to replace all the parts and components as necessary (Quoted separately)

#### **Roller Shutter Doors:**

- Service of the roller shutter doors once a year
- · Respond to call-out to do fault finding and quote on repairs when required
- Servicing of the motor and all moving parts including replacement if necessary
- Remove old grease, re-apply new grease on the tracks and the roller door frame needs to be stable
- Cleaning of doors to remove dust and sludge
- Check all electrical parts for damage & possible rust
- Check all securing bolts if they are tightly fitted and replace faulty ones if necessary
- Check all connections and switches for defects and replace if required
- Inspect and service shaft, bearings, and springs

# **Motorized Sliding Doors:**

- Yearly and adhoc servicing motorized sliding doors
- Respond to call-out to fault finding and quote on repairs when required
- Check and service motor and all moving parts including replacement if necessary
- Check the tension belts
- Check the wheel track
- Check the functionality of the sensors

Treatment of rust on all gates and roller shutter doors including electrical connections. Service provider shall provide the warranty on all replaced parts and services rendered.

The SABC reserves the right to test all quotes in the market and/or decline a quote from the contracted service provider.

The successful service provider will be expected to comply with SABC health and safety regulations

# 3. RFQ Response Information

#### Effective Date of Bid

Vendors should state in writing that their quotation to the SABC and all furnished information, including price, will remain valid and applicable for 90 days from the date the vendor quotation is received by the SABC.

# 4. Costing

The quotation must reflect a detailed cost breakdown, and any indirect costs associated with the rendering of required service as per the schedule in the Scope of Service.

#### 5. Duration of the Contract

Three (3) years contract

#### 6. Evaluation criteria

#### 6.1 BBBEE and Price

• The RFQ responses will be evaluated on the 80/20 points system

#### 6.2 Technical Evaluation

- The tender submission will be technically evaluated out of 70
- A minimum threshold of **70 out of a maximum of 100** has been set.
- Bidders achieving less than the set threshold will be declared non-responsive and therefore will not continue forward for evaluation of BBBEE & Price Preference.

# 6.3 Objective Criteria

- The SABC further reserve the right not to award this tender to any bidder based on the proven poor record of accomplishment of the bidder in previous projects within the SABC.
- Bidders who are blacklisted or have committed other acts of fraud and misrepresentation of facts e.g., tax compliance, BBBEE, company financials, etc. will be eliminated from the bid process.

# 9 COMMUNICATION

Respondents are warned that a response will be disqualified should any attempt be made by a tenderer either directly or indirectly to canvass any officer(s) or employees of SABC in respect of a tender, between the closing date and the date of the award of the business.

All enquiries relating to this RFQ should be emailed three days before the closing date.

#### 10 CONDITIONS TO BE OBSERVED WHEN TENDERING

10.1 The Corporation does not bind itself to accept the lowest or any tender, nor shall it be responsible for or pay any expenses or losses which may be incurred by the Tenderer in the preparation and delivery of his tender. The Corporation reserves the right to accept a separate tender or separate tenders for any one or more of the sections of a specification. The corporation also reserves the right to withdraw the tender at any stage.

10.2 No tender shall be deemed to have been accepted unless and until a formal contract / letter of intent is prepared and executed.

10.3 The Corporation reserves the right to:

Not evaluate and award submissions that do not comply strictly with his RFQ document.

# Make a selection solely on the information received in the submissions and

• Enter into negotiations with any one or more of preferred bidder(s) based on the criteria specified in the evaluation of this tender.

 Contact any bidder during the evaluation process, in order to clarify any information, without informing any other bidders. During the evaluation process, no change in the content of the RFQ shall be sought, offered or permitted.

Award a contract to one or more bidder(s).

• Accept any tender in part or full at its own discretion.

• Cancel this RFQ or any part thereof at any time.

 Should a bidder(s) be selected for further negotiations, they will be chosen on the basis of the greatest benefit to the Corporation and not necessarily on the basis of the lowest costs & Preference Point system.

# 11 Cost of Bidding

#### 1. CONSORTIUMS AND JOINT VENTURES

- 1.1 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as a legal entity, provided that the entity submits their B-BBEE status level certificate.
- 1.2 A trust, consortium or joint venture will qualify for points for their B-BBEE status level as an unincorporated entity, provided that the entity submits their consolidated B-BBEE scorecard as if they were a group structure and that such a consolidated B-BBEE scorecard is prepared for every separate tender.

#### 2 SUB-CONTRACTING

- 2.1 A person awarded a contract may only enter into a subcontracting arrangement with the approval of the organ of state.
- 2.2 A person awarded a contract in relation to a designated sector, may not subcontract in such a manner that the local production and content of the overall value of the contract is reduced to below the stipulated minimum threshold.
- 2.3 A person awarded a contract may not subcontract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level of contributor than the person concerned, unless the contract is subcontracted to an EME that has the capability and ability to execute the subcontract.

#### 1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to invitations to tender:

#### 1.2 To be completed by the organ of state

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

#### 2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and

- Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).<sup>2</sup> Collusive bidding is a *pe* se prohibition meaning that it cannot be justified under any grounds.
- 3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
  - a. disregard the bid of any bidder if that bidder, or any of its directors have abused the institution's supply chain management system and or committed fraud or any other improper conduct in relation to such system.
  - cancel a contract awarded to a supplier of goods and services if the supplier committed any corrupt or fraudulent act during the bidding process or the execution of that contract.
- This SBD serves as a certificate of declaration that would be used by institutions to ensure that, when bids are considered, reasonable steps are taken to prevent any form of bidrigging.
- In order to give effect to the above, the attached Certificate of Bid Determination (SBD 9) must be completed and submitted with the bid:

- <sup>2</sup> Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. Bid rigging is, therefore, an agreement between competitors not to compete.
