- The representative attending the compulsory pre-bid meeting / site briefing may only attend on behalf of one bidding enterprise and/or Joint Venture/Consortium/Trust.
- In the case of Joint Venture or consortium bidders, it must be noted that if, at the time they are invited to submit their quotation, the Joint Venture or consortium has dissolved, the bidders will still be required to submit their bid as the original Joint Venture/consortium and not as individual entities.
- Bidders are required to refer to the Framework, which forms an integral part of this tender document. The Framework provides detailed information on how the panel will be managed during the RFQ stage.

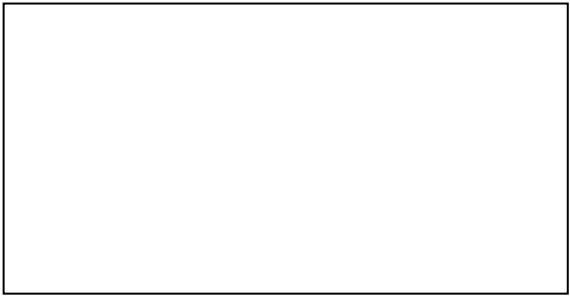

GDRT aims to achieve the best value for money when buying or selling goods and obtaining services. This however must be done in an open and fair manner that supports and drives a competitive economy. Underpinning our process are several acts and policies that any service provider dealing with GDRT must understand and support. These are:

This code of conduct has been included in this contract to formally appraise GDRT Service providers of GDRT's expectations regarding behaviour and conduct of its Service providers. The tenderer will share this code of conduct with its subcontractor(s) prior to submitting the tender and ensure adherence to it by the subcontractor(s).

***Prohibition of Bribes, Kickbacks, Unlawful Payments, and Other Corrupt Practices***

GDRT's aim is to become a world class provincial department. As such, our transformation is focused on adopting a performance culture and to adopt behaviours that will enable this transformation.

***1. GDRT will not participate in corrupt practices in any form or guise. Therefore, it expects its service providers to act in the same manner.***

GDRT and its employees will adhere the laws of this country and keep accurate business records that reflect actual transactions with, and payments to, our service providers.

GDRT Employees must not accept or request, agree or promise to accept, money, or anything of value, or any form of gratification, either directly or indirectly, from service providers or anyone linked to them in return for a benefit or other advantage to accrue to a service provider or other linked 3rd party.

Employees may not receive anything that is intended to:

There may be times when a service provider is confronted with fraudulent or corrupt behaviour of GDRT employees. We expect our Service providers to use our “Tip-offs Anonymous” Hot line to report these acts.

**2. *GDRT is firmly committed to the concept of free and competitive enterprise.***

Service providers are expected to comply with all applicable laws and regulations regarding fair competition and antitrust practices.

GDRT does not engage with non-value adding agents or representatives solely for the purpose of increasing BBBEE spend (fronting).

**3. *GDRT’s relationship with service providers requires us to clearly define requirements, to exchange information and share mutual benefits.***

- Generally, service providers have their own business standards and regulations. Although GDRT cannot control the actions of our service providers, we will not tolerate any illegal activities. These include, but are not limited to:
- Misrepresentation of their product (origin of manufacture, specifications, intellectual property rights, etc);
- Collusion in whatever form that is intended to influence procurement decisions.
- Failure to disclose accurate information required during the sourcing activity (ownership, financial situation, BBBEE status, etc.);
- Corrupt activities listed above; and
- Harassment, intimidation or other aggressive actions towards GDRT employees.
- Service providers will be evaluated and approved before any materials, components, products or services are purchased from them. A rigorous due diligence is conducted, and the service provider is expected to participate in an honest and straight forward manner.
- Service providers must record and report facts accurately, honestly and objectively. Financial records must be accurate in all material respects.

**3. GDRT's REQUIREMENTS (FRAMEWORK)**

**3.1 Introduction**

The Gauteng Province Department of Roads and Transport aims to accelerate the implementation of road infrastructure programmes through appropriate project management initiatives in the transport and road infrastructure sectors which are critical to the achievement of various national objectives for economic growth, job creation and mobility.

The Department further aims to contribute to sustainable livelihoods and economic growth by accelerating the delivery of quality social and economic road infrastructure and promoting cost-effective, sustainable, integrated road infrastructure planning and delivery.

**3.2 Overview of GDRT Requirements**

The Gauteng Province Department of Roads and Transport in executing projects uses the services of various disciplines and the service providers to achieve completion effective and efficient service delivery. These service providers are sourced from the market through competitive open bidding process published in the government tender bulletin.

The challenges associated with an open tender is that despite tight criteria, the volume of responses remains very high as every business puts forward its application that must be evaluated appropriately. The GDRT has experienced high volumes of tender responses in the past and this always surpasses the available resource capacity to evaluate on time, hence communication will be shared with prospective bidders on the process of completion.

The GDRT therefore in mitigating the above risks, considers appointing a panel of service providers for procurement of small plant, tools and accessories on an **as-and-when required basis**.

**3.3 Scope of Work**

This competitive open bidding process invites service providers to apply for inclusion on the Gauteng Department of Roads and Transport (GDRT) panel of service providers for the supply, servicing and maintenance of small plant, tools and accessories for all 5 regions in Gauteng for a period of three years.

Extent of the works:

The scope of work covers the supply, service and maintenance of small plant, tools and accessories to ensure compliance with applicable occupational health and safety regulations. #### **4.GDRT' PANEL FRAMEWORK**

##### **4.1 Objectives**

GDRT's objective is to put in place the panel of service providers for the supply, service and maintenance of small plant, tools and accessories for a period of three years

GDRT planned to achieve the above by entering into an agreement with panel of service providers over a three-year term with potential service providers for:

4.1.1 best value for money.

4.1.2 the sustainable supply of Services; and

4.1.3 the meeting of GDRT's current requirements (at a minimum) and providing for flexibility to meet GDRT's future needs related to the scope.

##### **Background**

Slow Supply Chain Management (SCM) practices contribute significantly delays in the project implementation, particularly in environments where services must be delivered efficiently and effectively. Inefficiencies in SCM processes often result in increased costs, slow response times, and compromised service quality. By contrast, efficient SCM practices that reduce costs, enable rapid responses to the delivery needs of the Gauteng Region, and ensure quality outcomes can play a critical role in improving the reliability and effectiveness of road services across Gauteng Province.

##### **4.2 Procurement Strategy**

**4.2.1** Appointment to the panel does not constitute a binding contract, nor does it impose any obligation on the Gauteng Department of Roads and Transport (GDRT) to procure services from any appointed panel member. Services will be provided strictly on an as-and-when-required basis, subject to the Department's needs and discretion.

**4.2.2** The Form of contracts with Bills of Quantities pricing strategy may be used by the employer later.

**4.2.7** The quotation enquiry document will contain all the relevant forms, the scope of work, pricing schedule and related information describing and defining the works, including any additional contract information.

**4.2.8 Additional requirements for the competitive procedure**

- (i) First Round of Competitive bidding - Respondents shall, in terms of a competitive selection process be evaluated against eligibility and functionality criteria.

- To ensure fairness, service provider will be allocated work on a rotational basis. **6.3.2.1** Engages in any collusive tendering, anti-competitive conduct, or any other similar conduct, including but not limited to any collusion with any other Bidder in respect of the subject matter of this bid;

**6.3.2.7** Has in the past engaged in any matter referred to in sub-paragraphs 6.3.2.1 - 6.3.2.6 foregoing; or

**6.3.2.8** Has been found guilty in a court of law on charges of fraud and/or forgery, regardless of whether a prison term was imposed and despite such Bidder, member or director's name not specifically appearing on the List of Tender Defaulters kept at National Treasury.

**6.3.3** GDRT in its sole discretion will be entitled (but not obliged) to exempt, in writing, a Bidder from disqualification in terms of subparagraph 6.3.2.7 foregoing. A Bidder that stands to be disqualified in term of sub-paragraph 6.3.2.7 foregoing may, prior to submitting a Tender, approach GDRT in writing for an exemption as foresaid, in which event:

**6.3.6.3** who had access to any of GDRT's proprietary information or any other matter that may have unfairly placed that Bidder in a preferential position in relation to any of the other Bidders.

**6.3.6.4** who materially fails to comply with any conditions or requirements of this bid.

### **7.2 Reservation of Rights**

GDRT reserves the right in its discretion to:

**7.2.3** not provide reasons for its rejection or the failure of any Bidder or Tender, save on application and in terms of applicable legislation.

**7.2.4** change any of its requirements as set out in this bid by giving Bidders reasonable notice.

**7.2.5** change any condition, procedure or rule of the bid by giving Bidders reasonable notice.

**7.2.6** amend, vary, or supplement any of the information, terms or requirements contained in this bid, any information or requirements delivered pursuant to this bid, or the structure of the bid process.

**7.2.7** re-advertise for Tenders.

**7.2.8** provide further information in respect of, and modify the provisions of, this bid at any time prior to the Closing Date by notice to all prospective Bidders.

**7.2.9** conduct site visits and/or perform audits whenever GDRT deems it prudent to do so during bid evaluation or post award.

**7.2.10** undertake further checks on Bidders, which may include information on public record or in the public domain, information contained in internal GDRT records or information received from other government institutions.

**7.4 Preparation Costs**

**7.5 Conflict of Interest**

If at any time the Bidder identifies an actual or potential conflict of interest, the bidder must immediately notify GDRT in writing. In addition, if it comes to GDRT's knowledge that there was indeed a conflict of interest or a potential conflict of interest, same will be grounds for the immediate disqualification of the Bidder, whether during the tender process or post appointment if successful.

**7.6 Confidentiality**

**1. INTRODUCTION**

This agreement is part of the tender document, which shall be signed and submitted along with the tender document. The Chief Executive Officer of the bidding company or his/her authorised representative shall sign the integrity pact. If the winning bidder has not signed this integrity pact during the submission of the bid, the tender/proposal shall be disqualified.

**2. OBJECTIVES**

Now, therefore, the Gauteng Provincial Government and the Bidder agree to enter into this pre-contract agreement, hereinafter referred to as an integrity pact, to avoid all forms of corruption by following a system that is fair, transparent, and free from any influence/unprejudiced dealings before, during and after the currency of the contract to be entered, with a view to:

- 2.1 Enable the Gauteng Provincial Government to obtain the desired contract at a reasonable and competitive price in conformity to the defined specifications of the works, goods and services; and
- 2.2 Enable bidders to abstain from bribing or any corrupt practice to secure the contract by assuring them that their competitors will refrain from bribing and other corrupt practices and the Gauteng Provincial Government will commit to preventing corruption, in any form by their officials by following transparent procedures.

**3. GOVERNANCE**

- 3.1 The integrity pact seeks to ensure that both parties comply with all applicable provincial, national, continental, and international laws and regulations regarding fair competition and anti-corruption.

**4. ENVIRONMENT**

- 4.1 The integrity pact requires that both parties comply with all applicable environmental, health, and safety regulations.

**5. PROTECTION OF INFORMATION**

- 5.1 The integrity pact seeks to ensure that both parties undertake to protect the confidentiality of information. Each party, when given access to confidential information as part of the business relationship, should not share this information with anyone unless authorised.

**6. REPUTATION**

- 6.1 The Gauteng Provincial Government wants to work with bidders who are proud of their reputation for fair dealing and quality delivery.
- 6.2 The Gauteng Provincial Government wants to ensure that working with government is reputation enhancing for the supplier.

- 6.4 The Gauteng Provincial Government further requires its bidders/suppliers to always adhere to ethical conduct even outside their contractual obligation with the Gauteng Provincial Government.

- 8.1.6 Following the report on the violation of the above clauses by the official(s), through any source, the GPG shall investigate allegations of such violations against the official or other role players and when justified:
- Take steps against such official and other role players (necessary disciplinary proceedings, and/or any other action as deemed fit, bar such officials from further dealings related to the contract process). In such a case, while an enquiry is being conducted by the Gauteng Provincial Government, the proceedings under the contract would not be stalled.

**9. COMMITMENTS OF THE BIDDERS**

The bidder commits himself/herself to take all measures necessary to prevent corrupt practices, unfair means and illegal activities during any stage of his/her bid or during any pre-contract or post contract stage to secure the contract or in furtherance to secure it and commits himself/herself to the following:

- 9.1 The bidder is committed to doing business with integrity and proper regard for ethical business practices.
- 9.2 The bidder will not offer, directly or through intermediaries, any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducements to any official of the Gauteng Provincial Government, connected directly or indirectly with the bidding process, or to any person, organization or third party related to the contract in exchange for any advantage in the bidding, evaluation, contracting and implementation of the contract.
- 9.3 The bidder further undertakes that he/she has not given, offered or promised to give, directly or indirectly any bribe, gift, consideration, reward, favour, any material or immaterial benefit or other advantage, commission, fees, brokerage or inducements to an official of the Gauteng Provincial Government or otherwise in procuring the contract or forbearing to do or having done any act in relation to the obtaining or execution of the contract or any other contract with the Gauteng Provincial Government for showing or forbearing to show favour or disfavor to any person in relation to the contract or any other contract with the Gauteng Provincial Government.
- 9.4 The bidder will not collude with other parties interested in the contract to preclude the competitive bid price, impair the transparency, fairness and progress of the bidding process, bid evaluation, contracting and implementation of the contract.
- 9.5 The Bidder(s)/Contractor(s) will not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
- 9.6 The Bidder(s)/Contractor(s) will, when presenting his / her bid, disclose any and all payments he /she has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
- 9.7 In case of sub-contracting, the Principal Contractor shall take the responsibility of adoption of Integrity Pact by the Sub-Contractor.
- 9.8 The bidder shall report any attempted or completed violation of clauses 9.1 to 9.7 including any alleged unethical conduct to the Gauteng Ethics Hotline (details are provided at clause 8.1.4).

9.9.1 It has not been convicted by a court of law for fraud and/or corruption with respect to the procurement/tendering processes; and/or

9.9.2 It has not been convicted by a court of law for theft or extortion; and/or

9.9.3 It is not listed on the National Treasury's database of Restricted Suppliers or Register of Tender Defaulters.

**10. SANCTIONS FOR VIOLATION**

10.1 The breach of any aforesaid provisions or providing false information by employers, including manipulation of information by evaluators, shall face administrative charges and penal actions as per the existing relevant rules and laws.

10.2 The breach of the Pact or providing false information by the Bidder, or anyone employed by him, or acting on his behalf (whether without the knowledge of the (Bidder), or acting on his/her behalf, shall be dealt with as per the provisions of the Prevention and Combating of Corrupt Activities Act (12 of 2004).

10.3 The Gauteng Provincial Government shall also take all or any one of the following actions, wherever required:

- To immediately call off the pre-contract negotiations without giving any compensation to the bidder. However, the proceedings with the other bidder(s) would continue.
- To immediately cancel the contract, if already awarded/signed, without giving any compensation to the bidder.
- To recover all sums already paid by the Gauteng Provincial Government.
- To cancel all or any other contracts with the bidders and GPG shall be entitled to demand and recover from the Contractor liquidated damages of the Contract value.
- To submit the details of the bidder to the National Treasury to register on the database for tender defaulters.

**11. CONFLICT OF INTEREST**

11.1 A conflict of interest involves a conflict between the public duty and private interest (for favor or vengeance) of a public official, in which the public official has private interest which could improperly influence the performance of their official duties and responsibilities. Conflicts of interest would arise in a situation when any concerned members of both parties are related either directly or indirectly or has any association or had any confrontation. Thus, conflict of interest of any tender committee must be declared in a prescribed form.

11.2 The bidder shall not lend or borrow any money from or enter any monetary dealings or transactions, directly or indirectly, with any member of the tender committee or officials of the Gauteng Provincial Government, and if he/she does so, the Gauteng Provincial Government shall be entitled forthwith to rescind the contract and all other contracts with the bidder.

- 12.1 The actions stipulated in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal proceedings.

**13. VALIDITY**

- 13.1 The validity of this Integrity Pact shall cover the tender process and extend until the completion of the contract to the satisfaction of both the Gauteng Provincial Government and the bidder (service provider).
- 13.2 Should one or several provisions of the Pact turn out to be invalid; the remainder of this Pact remains valid. In this case, the parties will strive to come to an agreement to their original intentions.
