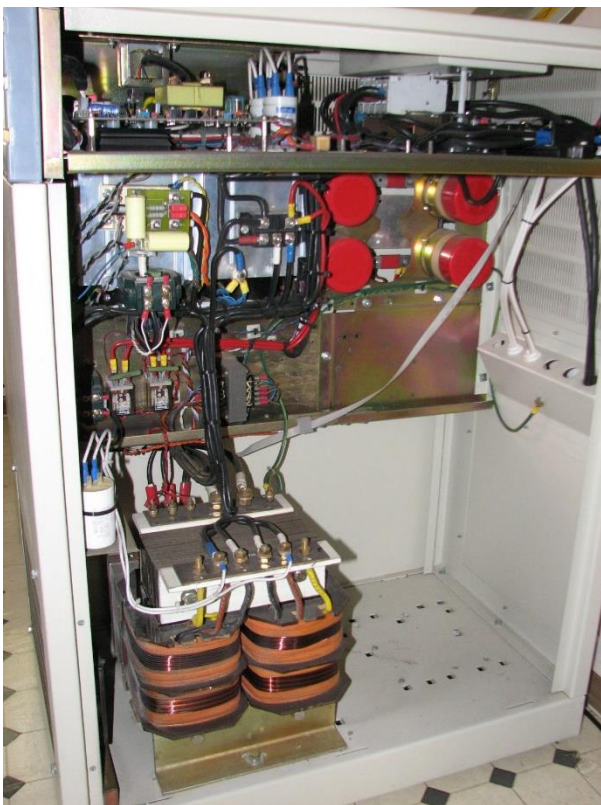


Figure 2: Library DB

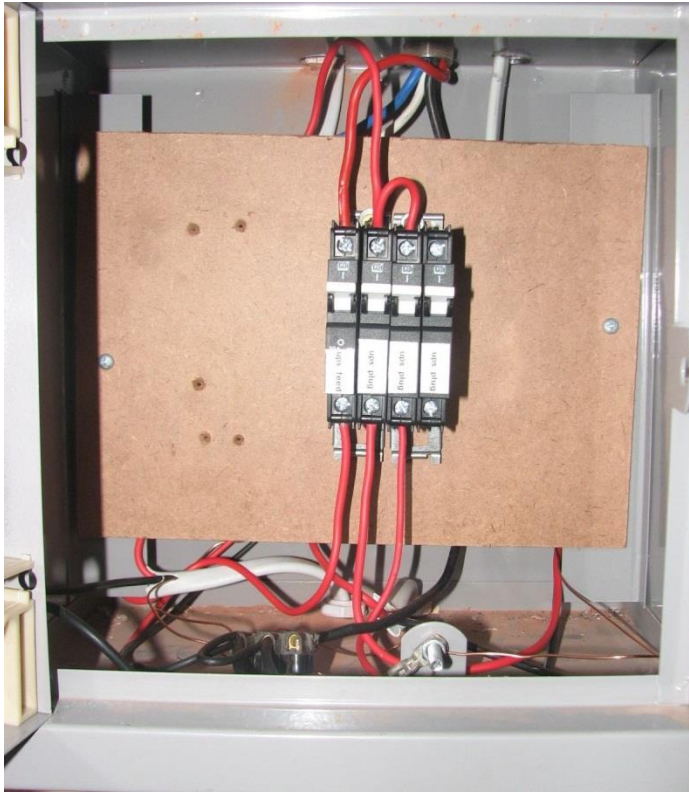


*Figure 7: Mechanization Tractor Lab - Plugs*

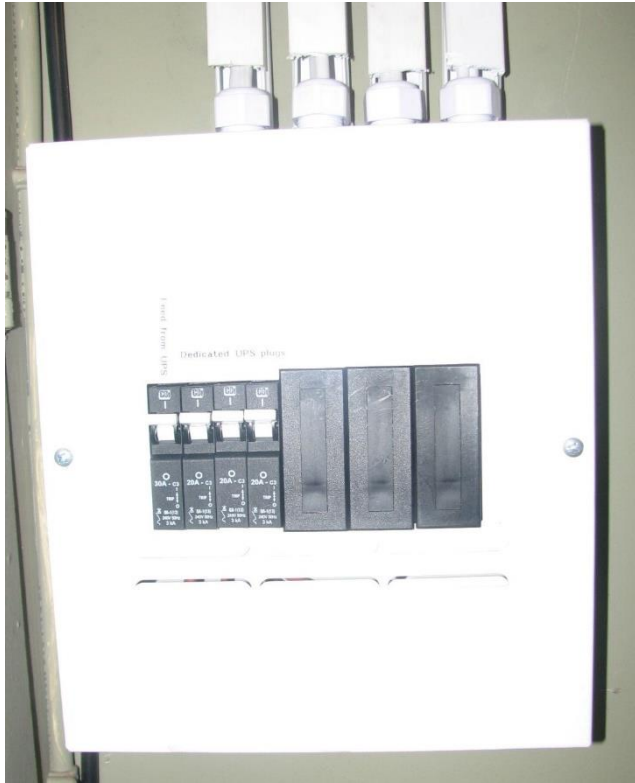


Figure 11: White building DB
