The South African Bureau of Standards (SABS) hereby invites you to submit a quotation for the provision of HC process redesign and mapping solution services.

1. Background

The SABS is a statutory body established in term of Standards Act, 1945 (Act No. 24 of 1945) and continues to operate in terms of the Standards Act, 2008 (Act No. 8 of 2008) as the national standardization institution in South Africa, mandated to:

- develop, promote and maintain South African National Standards;
- promote quality in connection with commodities; and
- render conformity assessment services and matters connected therewith.

2. Request for Quotation (RFQ)

This RFQ serves as an invitation to submit a quotation for **the provision of HC process redesign and mapping solution services** subject to the SABS Standard Terms and Conditions, of which a copy is available on www.sabs.co.za/procurement/proc toc.asp

The Bidder is requested to supply its quotation, in writing, by the date specified. Should the Bidder require any clarification, the clarification should be submitted by e-mail to the Procurement Specialist identified in this document.

By submitting a quotation in response to this RFQ or participating in this RFQ process, the Bidder accepts that it is subject to and bound by all the terms and conditions contained in this RFQ document.

3. Confidentiality

This document may not be used for any purpose by the Bidder other than for developing their response to it, and all reasonable efforts must be taken by the Bidder to ensure confidentiality of any information provided. This document and any other information of a confidential nature provided to the Bidder during the course of RFQ process are and will be covered by the non-disclosure agreement to be signed between the SABS and the Bidder.

4. No Contract

Bidders shall note that this RFQ does not commit the SABS to any course of action resulting from the receipt of quotations and the SABS may, at its discretion reject any submission which does not conform to instructions and specifications which are contained herein or select a Bidder based upon its own unique set of criteria. The SABS also reserves the right not to select a bidder.

Nothing in this document shall be construed as a contract between the SABS and the Bidder, and no communication, whether verbal or written, by the SABS personnel or agents during the course of this process shall create such a contract in respect of the requirements specified in this RFQ.

5. No Obligation to Proceed

The SABS reserves the right to discontinue the RFQ evaluation process at any time and will not be responsible for any losses incurred by the Bidder as a result of discontinuance of the RFQ process

6. Validity of Proposals

The Bidder's quotation shall remain valid for a period of one hundred and twenty (120) days from the closing date. The SABS may at any time prior to the expiry of the bid validity period, extend the above validity period by sixty (60) days by written notice to the Bidders. In that event, the SABS will not require any consent from the Bidders, and bidders will not be required or permitted to amend any of their quotations.

The SABS retains the right, but is under no obligation, to request Bidders to extend the validity periods of their quotations, prior to expiry thereof, if it has already invoked the extension referred to above and it is in the SABS' interest to further extend the bid validity period. Such request shall be in writing. The Bidder is not obliged to extend the validity period. Also, bidders will not be required or permitted to amend any of their quotations.

7. Scope of Work

Background

The SABS Human Capital (HC) division requires a HC Process redesign and mapping solution service from potential bidders to assist in optimizing and supporting the SABS strategy.

This RFQ serves as an invitation to submit a quotation for the appointment of a service provider to provide HC Process redesign and mapping services to the SABS in accordance with the SABS Standard Terms and Conditions

Scope of services

The successful service provider will be expected to perform HC process redesign and mapping solutions, but not limited to the following:

The successful bidder will be required to:

- Review all current HC processes in line with current HR best practice
- Map and redesign all HC processes
- Develop an integrated (yet practical) HR service delivery process framework considering
 the newly designed process maps and the new SABS HC structure (SABS Human Capital has
 a new HR structure and operates based on the HC Business Partner delivery model i.e., HC
 Business Partnering, Shared Services and HC Centre of Excellence)
 - The integrated framework must include best practice implementation of the HC Business Partnering model.
 - The framework should indicate the major tasks and duties of HC Business Partnering, Shared Services and HC Centre of Excellence, the dependencies between each area and the process flow between each area as it pertains to each of the various process maps.

- The process maps must consider the current HC systems (CRS, Signify & JEasy) and current SABS HC policies and procedures and leverage this to simplify tasks.
- Conduct a training workshop (1-2 days) for the HC team to effectively map and design HC processes in the future.
 - This workshop must cover how to map internal customer behaviour to ensure accurate process mapping in the future.
 - o This workshop must also cover how to properly map HC processes in the future.
 - The workshop must also cover how to properly implement and integrate the HC
 Business Partnering model and the daily and monthly task-level touchpoints between
 HC Shared services, HC Business Partnering and HC Centre of Influence.
- Develop and provide a process redesign and mapping learner manual (containing process redesign toolkits, process mapping steps, process framework integration, etc.) and presentation slides for the workshop.
 - o The learner manual must be provided in both digital and hard copy format.
 - o The presentation slides must also be provided.
- Provides a step-by-step project implementation plan to ensure HC processes are redesigned and mapped within SABS as soon as possible.

Turnaround Times

Successful bidder(s) must ensure that:

- The full process does not take longer than three (3) months.
- A comprehensive written close-out report outlining the outcomes (results, further value-add recommendations, impact analysis of current HC process maturity vis-à-vis best practice and any additional observations) is provided to SABS Human Capital after implementation.

SABS reverse the right to conduct site visits to shortlisted Bidder(s) to validate the bidders' capability to render the service.

Only Bidders who meet the minimum threshold of 70% on technical requirement will be evaluated further on 80/20 preference points system of 2022. (**Pricing and Specific Goal**)

Under no circumstances shall the SABS be responsible for any of the Bidder's costs associated with the preparation and/or submission of its quotation, including any costs incurred by the Bidder prior to the signature, by both parties, of an agreement resulting from a successful bid.

The SABS will not be bound by any legal or contractual terms as may be included in the Bidder's quotation, in response to this RFQ.

This preference form must form part of all tenders invited. It contains general information and serves as a claim form for preference points for specific goals.

1. GENERAL CONDITIONS

- 1.1 The following preference point systems are applicable to invitations to tender:
 - the 80/20 system for requirements with a Rand value of up to R50 000 000 (all applicable taxes included); and
 - the 90/10 system for requirements with a Rand value above R50 000 000 (all applicable taxes included).

1.2 To be completed by the organ of state

- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
