1. BACKGROUND INFORMATION

The Oil, Coal, Water and Microbiology Laboratories in Research, Testing & Development (located in Rosherville, Johannesburg) conduct specialised testing on oil, coal, ash and water samples for the business. In order to conduct these tests/analyses, laboratory instruments are used which requires the use of certain gases to operate.
