Detailed Organogram, breakdown of personal and relevant experience to this scope</p> <p>Tenderer to submit detailed methos statement (of how the contractor is going to carry out the works in a safe and meeting the plumbing requirements and standards.</p> <p>NB – Method statement should cover these aspects below.</p> <ul style="list-style-type: none"> <li>• Methodology</li> <li>• Safety aspects</li> <li>• Environmental</li> <li>• Quality aspects</li> </ul> <p>Organogram &amp; methods Statements =20% Organogram only = 5% Method statements only = 15% No submission -0%</p> <ul style="list-style-type: none"> <li>• Documents submitted must be of quality, and reflects core skills of executing the work</li> </ul>

Qualification to be certified not older than 3 months.</p> <ul style="list-style-type: none"> <li>• 1 x Plumber Artisan with plumbing Trade Test certificate with min 5 years' experience CV-10%</li> <li>• 1x Supervisor CV with Technical Qualification in civil/building diploma with min 5 years construction works experience -10 %</li> <li>• 1x Safety Officer with a safety management diploma with min 5 years' experience CV- 10 %</li> <li>• 2 x Assistance Utility Personnel with a matric and 3 years plumbing works experience -5 %</li> </ul>
