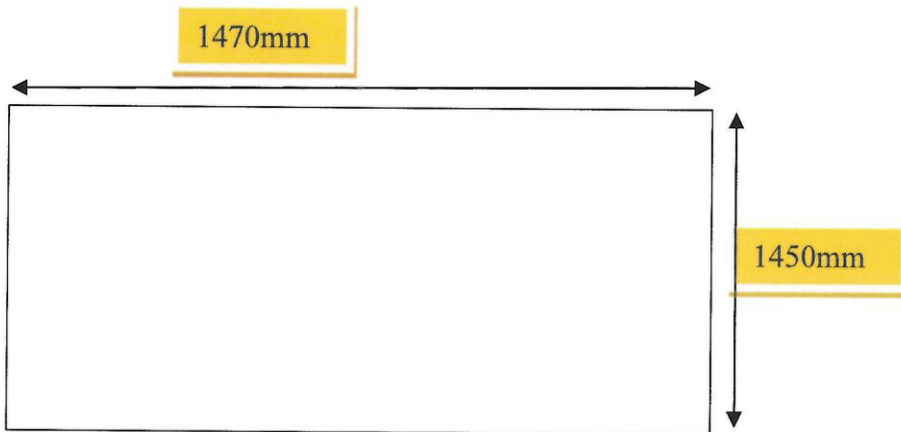

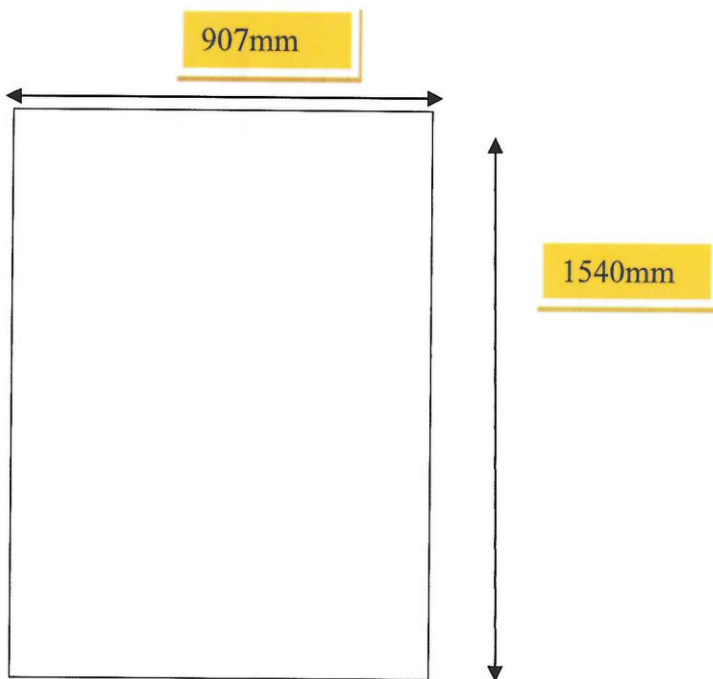

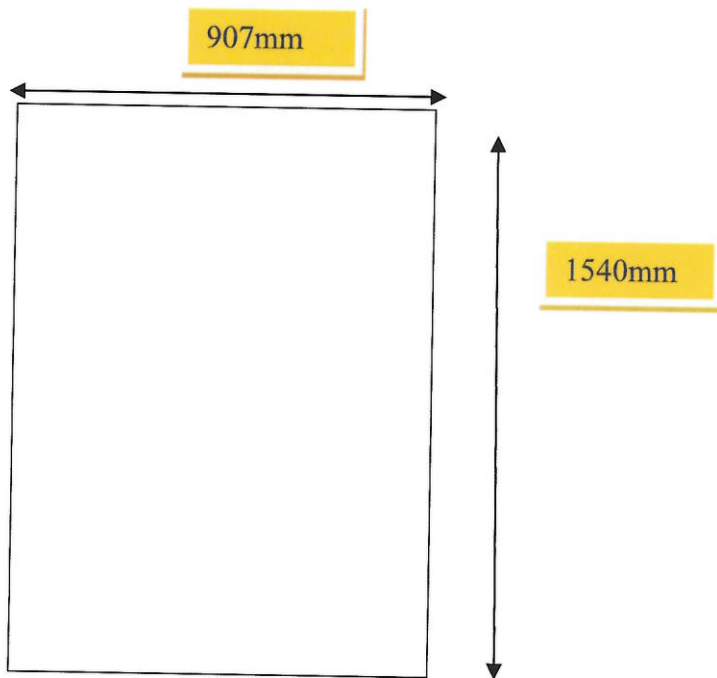

WINDOW 2



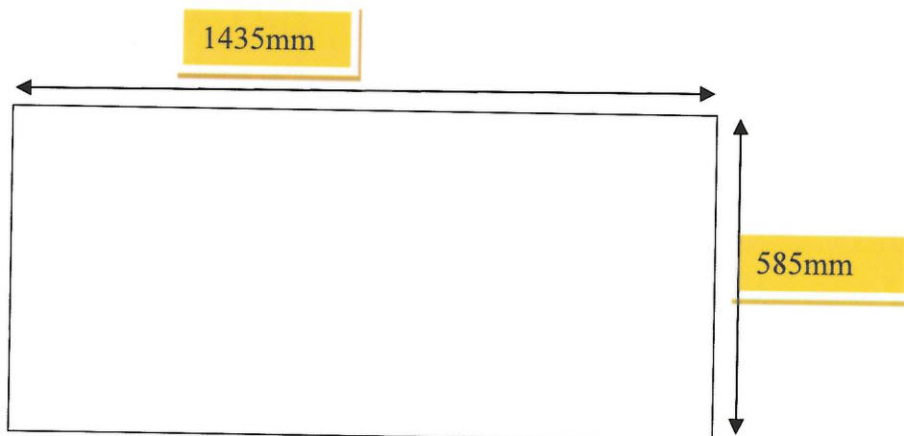

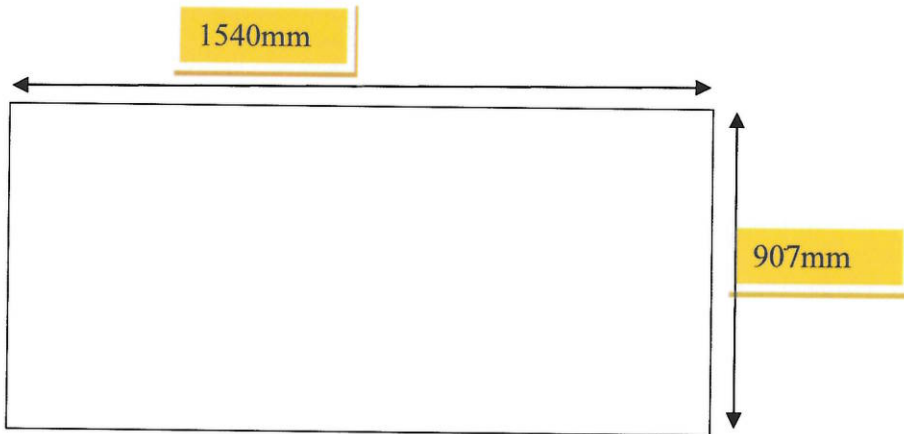
