1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to invite qualified service providers to submit a proposal and quotation for the provision of advisory services relating to Employee-benefits-tax matters as detailed in the scope of work.

2. BACKGROUND

South African National Parks (SANParks) is a public entity, established under National Environmental Management: Protected Areas Act 57 of 2003 (Act 57 of 2003), with the mandate to manage national parks and other defined protected areas. As a public entity, SANParks is also governed by the Public Finance Management Act, Act 1 of 1999 (as amended by Act 29 of 1999), and it is listed as Schedule 3 Part A: public entity.

The primary mandate of SANParks is to expand, protect, conserve, and control the system of national parks, terrestrial and marine, that it is assigned to manage. SANParks currently manages over 4 million hectares of terrestrial and 369 657 ha marine protected biodiversity through a system of 21 National Parks and 10 Marine Protected Areas: (MPAs), representing approximately 67% of state owned terrestrial protected areas and 22% of State Managed MPAs.

The Parks under the management of SANParks are divided into 6 regions:

3. SCOPE OF WORK

BACKGROUND

SANParks' business is carried out across South Africa at 21 national parks, which are mostly situated in remote areas, away from the convenience and amenities of cities (housing, schools, hospitals, shops, etc.). For employees to meet the operational needs and perform their duties, employees are often required to leave their place of residence and move to the parks where SANParks provides employees with the necessary facilities, amenities and support, which include accommodation, transport to school, boarding school fees subsidies etc.

This is where the organisation provides the benefits to its employees faced with this reality. SANParks then provides services such as accommodation, transport to school, boarding school fees subsidies etc. Attached is a schedule that describes all these benefits and whether employees are currently being taxed for them:

REQUIREMENTS/ DELIVERABLES

The respondent is required to provide suggestions on how the salary packages can be structured to have the best tax benefits for employees. Furthermore, the bidder must provide advice on rectifying the historic and current non-compliance on Fringe benefits provided to its employees and, where applicable, advise SANParks if:

- There are tax efficient ways that fringe benefits can be structured.
- Any nil value provisions apply as per Seven Schedule of the Income Tax Act No.58 of 1962.
- Tax directives can be applied for in respect of the accommodation fringe benefits.
- A non-binding private opinion must be applied for to obtain clarity from SARS where legislation is unclear.

If applicable, the responded must prepare and submit a VDP application to SARS which includes:

1. Calculating the estimated fringe benefits tax liability of SANParks up to 5 years prior
2. Preparation of a cover letter to SARS detailing the tax exposures and completion of the VDP form
3. Liaise with SARS post the VDP submission and attend to any requests made by SARS.

4. COMPLIANCE AND GOVERNANCE VERIFICATION DOCUMENTS (Standard Bidding Documents)

The verification during this phase is to assess the bid responses for purposes of verifying compliance with RFQ requirements, whereby a bidder may be disqualified if they do not fully comply with requirements as stipulated below:

- 1.2 The applicable preference point system for this tender is the **80/20** preference point system.
- 1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:
- (a) Price; and
 - (b) Specific Goals.

1.4 The maximum points for this tender are allocated as follows:

1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.

1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;

4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
