Guidelines on Specification for Procuring Services

Guideline for Terms of reference

This tender is for the appointment of a Panel of 08 Contractors for repair or replacement of collapsed sewer and water pipeline for a period of three years (as and when required) within Moqhaka Municipality for a period of 3 years.

A. Background

The Technical Department (Water and Sanitation) division experience a challenge of aged clay sewer pipes and old AC pipe that need serious and urgent repair or replacement, this also need certain equipment's to execute the work which the municipality does not have capacity to do. This affect the service delivery negatively and put more financial stress to the municipality which lead to countless deviation which is the finding. Some of the sewer pipelines are running under the building in a private property which makes even more difficult do perform maintenance or repairs if need be.

B. Scope of Work / Terms of Reference

The service provider must: be able to replacement and repair of:

- SEWERAGE PIPELINE:

 150 mm to 600 mm
 Class 12 to class 32 heavy duty UPVC

 Use CCTV camera for the inspection of the lines
- WATER PIPELINE: 150mm to 700mm Class 12 to 24 UPVC pipe Pipe Jacking

Refer to Annexure B for the Bill of Quantities / Pricing Schedule.

Tender prices to be fixed for the first twelve (12) months and escalation will be provided for as per the Service Level Agreement (SLA) from the second (2^{nd}) year and third (3^{rd}) year.

C. Panel

In this panel, the municipality will appoint a maximum of <u>8</u> service providers who scored the highest points scored in terms of the Preferential Procurement Policy of Moghaka Local Municipality.

D. Sourcing of Quotations

Quotations will be requested only from the service providers appointed on the panel on a **rotation basis** to ensure all service providers appointed on the panel have an opportunity of being selected during the contract period.

Should the service providers on the panel not be in a position to supply the required service within the desired timeframes, the municipality will deem it necessary to invite quotations outside the appointed panel.

The municipality will derive a flat rate from the prices submitted by the successful bidders. This flat rate will be offered to the bidders through a negotiation process. This will assist the municipality with a fair and equitable process of rotation. This will also prohibit the municipality from paying more for the same product between service providers on the panel.

E. Performance Management

In terms of Section 116 (2) of the MFMA, the municipality is required by Law to monitor the performance of service providers on a monthly basis in line with the performance areas as stipulated in the Service Level Agreement (SLA). The monitoring of panels will be done as and when their services are utilised.
