1. Scope of Work and Overview

The scope covers the following as discussed by the Technical Representative Mr Frikkie van Loggerenberg.

Peaking Operating Unit requires a Cost-effective National Courier services for the pick-up, transport, delivery and off-loading of products, parcels, documentation, parts, materials and goods. Courier services required will be to and from any of the Peaking Power stations and offices situated throughout South Africa.

2. The various stations are:

Acacia Power Station is located in Capetown

Ankerlig power station is located in Atlantis

Palmiet Power Station in located in Grabouw

Gourikwa Power station located near Mosselbay

Small Hydro's in Zimbane Electricity House, Mthatha, Eastern Cape

Sere Windfarms -

The Sere Wind Farm is located close to the town of Koekenaap and falls within the Matzikama Municipality, in the Western Cape, South Africa. The Windfarm's precise location is in Lot 1862 Olifants River Settlement as shown in Figure 1 below. GPS Co-ordinates (31.5288513S 18.1925658E).

The nearest major town from the Windfarm is Vredendal, which is located 55km away. The distance between Sere Wind Farm and Cape Town International Airport is 356km via the N7.

In the Eastern Cape Port Rex Power station is located in East London

In the Northern Cape Vanderkloof Power Station is located near the town Vanderkloof

In the Free State Gariep Power station is located near Gariep dam

In KwaZulu Natal Drakensberg power station is located near Bergville

Ingula Power station is located near Ladysmith (Approximately 50km)

9. SHE (Safety Health Environment) and Quality returnables attached on the Tender Bulletin to be returned with the tender were discussed. If all SHE and Quality Returnables are not submitted, they can still be requested after the tender closing date.

10. Questions raised during the meeting

- a) In the case of a joint venture, if you are joint venturing with a courier company can the courier service's company details be made applicable?
 - b) In the event that a joint venture breaks up, this is a risk for Eskom, but if this is a legally drafted JV where the other part is held liable, this can be considered, so documents such as legal binding contracts to be submitted, but each case will be judged on it's own merits.
 - c) Clarity was provided on item 2 Company Profile above, where there is a total weighting of 15%. The weighting is 20% but the scoring if 15% in total it will weight 20% of the total weighting.
 - d) A Fuel Levy was brought up by an attendee to mitigate risks in terms of Fuel/Diesel. A fuel levy has been included on the revised price list. Each Supplier to indicate their respective Formulas that will be used to determine fuel levy.
 - e) An attendee also requested an indication of the outlying areas, and this is included on the updated NEC in section 3.2.1.
11. The updated NEC with the revised Price Lists Is attached. This includes the fuel levy on section 2.2 and in section 4.1. the outlying areas is included in section 3.2.1.
12. Domestic bulk Cargo and Same Day? What is the difference thereof? The revised price list is attached with Domestic Bulk Cargo separated.
13. Record of collection and deliveries during the last Year to give Suppliers an idea of movements, and Regions to assist Suppliers with Costing. **This will be sent by tomorrow 5 April 2022 or the latest 06 April 2022 to the attendees and posted on the Tender Bulletin.**
14. Insurance (Percentage of parcel Value) is included in the revised price list in the event requirements for insured parcels. This is Optional when requested or indicated by the client and provision is made in the revised price list for Suppliers to make provision therefor. This was clarified and mentioned that this is the declared value of the parcel not the Courier Fee.
15. Set Collections and Deliveries. All Deliveries are Ad-hoc, and not set, Tender Documents might be more frequent to the Power Stations, but this is ad-hoc.
16. The closing time for clarification of queries is five (5) working days before the deadline for tender submission.
