SFF is a wholly owned subsidiary of CEF established by the Government and came into operation in 1977. The entity is mandated by the Minister of Energy to manage and control the Strategic stocks, Strategic assets, and commercialization of the assets to fund the government mandate

SFF Clearing and Forwarding Services – Scope of work – Saldanha Bay and Milnerton Terminals for 36 months.

1. BACKGROUND

SFF leases the available ullage in both the Milnerton and Saldanha Bay terminals on a commercial basis to fund its strategic mandate. Part of the value-added services which SFF provides its lessees is the provision of Clearing and Forwarding services to declare to SARS, National Treasury and TNPA all imports and exports destined for both the terminals.

2. SCOPE OF WORK

The Clearing and Forwarding contractor provides comprehensive documentary clearing and forwarding services for SFF imports, exports and local SA movements of crude oil which includes but is not limited to the following.

- a) Pre-clearing Customs Documentation,

ANNEXURE 4

Certificate of Independent Bid Determination (SBD 9)

- 3.1. This Standard Bidding Document (SBD) must form part of all bids¹ invited.
- 3.2 Section 4 (1) (b) (iii) of the Competition Act No. 89 of 1998, as amended, prohibits an agreement between, or concerted practice by, firms, or a decision by an association of firms, if it is between parties in a horizontal relationship and if it involves collusive bidding (or bid rigging).² Collusive bidding is a *pe se* prohibition meaning that it cannot be justified under any grounds.
- 3.3 Treasury Regulation 16A9 prescribes that accounting officers and accounting authorities must take all reasonable steps to prevent abuse of the supply chain management system and authorizes accounting officers and accounting authorities to:
