Nkandla Local Municipality subscribes to the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000). The 80/20 preference system shall be applicable during the evaluation and adjudication of bids. The amended PPFFA regulation 2022 will be used.

First stage: Functionality 100 points (Minimum threshold of 70 points) being 50 points for experience and 50 points for capacity.

Second stage: Preferential points system (80/20): 80 points for price and 20 points for specific goals (Ownership and FDP Goals). Only bidders who pass the first stage with a minimum of 70 points will then be evaluated further in the second stage. (Detailed evaluation criteria contained in the tender document).
