2. SCOPE OF WORK

2.1 Background:

NRWDI seeks to appoint a service provider to review the draft set of financial statements prepared by NRWDI before handover to the external auditor. This is a financial audit with a maximum of 50 hours. The review is about analysing the NRWDI AFS for GRAP compliance and therefore needs to ascertain the following:

- i. Best quality of 2025/26 Annual Financial Statements.
- ii. That the AFS agrees to prior year audited AFS, Annual Report and including accounting adjustment required.
- iii. That the prior year errors and disclosure thereto are correct.
- iv. That the AFS are correctly casted and cross-casted.
- v. That the notes to the AFS are properly numbered and correctly linked to the AFS
- vi. Adequacy of information contained in the audit file.
- vii. That the AFS agrees to the fixed asset register, debtors age analysis and other supporting documentation contained in the audit file.
- viii. That all the financial information is recorded.
- ix. Obtain trial balances and determine whether it is aligned to the general ledger and the financial statements.
- x. That the accounting policies and policies adopted by Board are in place,
- xi. Comply with GRAP standards and are applied appropriately.
- xii. That the accounting policies are applied consistently and/or that the disclosure notes have been made where applicable.
- xiii. That actions taken at the Board meetings that have affected the financial statements have been appropriately reflected.
- xiv. That all applicable disclosure notes are included in the annual financial statements

2.2 Activity Schedule:

NRWDI will provide the draft statements and balances to the contracted service provider for review and advice. The service provider is expected to review and advise the draft statements and provide NRWDI with review notes and comments. NRWDI will then address the notes obtained and re-submit revised information for further review. The service provider will then issue the final comments on the documents.

2.4 Deliverables:

The deliverables will include reviewed draft statements with comments and the final draft AFS that will be handed to the external audit team. Invoicing and payment will be done after the work is completed.

EVALUATION CRITERIA

The evaluation will be carried out in three Phases:

- Phase 1: Mandatory Requirements (At Closing Stage)
- Phase2: Price and Specific Goals
- Phase 3: Mandatory Requirements (At Award Stage)

1. Mandatory Requirement (At RFQ Closing Date)

- i. Service Providers who will fail to quote fully or according to the specification/scope of work will be disqualified.
- ii. Quotation submitted after the closing date and time.
- iii. Quotations that are not sent through the procurement central email will not be considered for evaluation.
- iv. Submit ID copies of the owners/directors of the bidding company as reflected on official registration documents e.g CIPC, CSD Report or BBBEE Certificate / Affidavit.
- v. The lead accountant must be chartered accountant, submit evidence.
- vi. The lead accountant must have minimum of 5 years’ experience in reviewing financial statements (submit CV)
- vii. The lead accountant must be a member in good standing of SAICA or IRBA, submit evidence.

2. Price and Specific Goals Evaluation

- Service providers that will comply with all the mandatory requirements at closing stage will be evaluated further on price (80 points) and specific goals (20 points) in terms of the 80/20 preference points system in line with the Preferential Procurement Regulations, 2022.
- The 80/20 preference point system will be applied to evaluate the received quotations.
- Price will be evaluated on 80 points and 20 points will be allocated to specific goals as illustrated on SBD 6.

1. GENERAL CONDITIONS

1.1 The following preference point systems are applicable to invitations to tender:

1.2 The applicable preference point system for this tender is the **80/20** preference point system.

1.3 Points for this tender (even in the case of a tender for income-generating contracts) shall be awarded for:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“black people”** is a generic term which means Africans, Coloureds and Indians—
- a) who are citizens of the Republic of South Africa by birth or descent; or
 - b) who became citizens of the Republic of South Africa by naturalisation—
 - i) before 27 April 1994; or
 - ii) on or after 27 April 1994 and who would have been entitled to acquire citizenship by naturalisation prior to that date;
- (b) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (c) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (d) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (e) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (f) **“the Act”** means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000); and
- (g) **“women”** means a person of female gender who is a citizen of the Republic of South Africa.

3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

3.1. POINTS AWARDED FOR PRICE

3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
- (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
