### 1 **Agreement**

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 90 days of the date of notification by the JB Marks Local Municipality that his/her bid has been accepted.

### 2 **Completion of Bid Documents**

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

### 3 **Alteration or Qualification of Bid**

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before closing date.

### 4 **Authorised Signatory**

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorizing the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorized to sign it for and on behalf of the bidder.

### 5 **Submission of Bid**

### 6 **Opening, Recording and Publications of Bids Received.**

**1.1** The appointed service providers into the panel will be called on an as and when basis to assist the Electrical Department with regard to work on the electricity distribution network's both the underground systems and overhead network. The works will be done on systems of the following voltages

**1.1.1** HV (132 kV) Network that includes lines and structures excluding substations.

**1.1.2** MV (11 / 66 kV) Network including lines and structures excluding substations.

**1.1.3** LV (400 V) Network including minis substations, distribution kiosks, connection, streetlights, cables that forms the complete council infrastructure with reference to the following;

**2. INTENT OF THE SPECIFICATIONS**

2.1 This contract makes provision for the

2.2 The purpose of this bid is to appoint a service provider or service providers to do breakdown maintenance and repair work on a call-out basis on house connections, 400 V network and 11 kV up to 132 kV network and structures. This call out shall be within one hour of notification that shall be by a duly delegated council official, to issue such notification, to render a service when the council capacity and resources are limited.

2.3 The objective of this contract is that the appointed contractor shall avail all the necessary personnel, equipment and transport on a monthly 24/7 call out basis.

2.4 The project will cover the JB Marks Local Municipality electrical infrastructure area in both regions.

3. Acceptance of the Tender by JB Marks Local Municipality or any part of it and the issue of an official order by JB Marks Local Municipality to the successful bidder will serve as a binding contract between both parties.
